# **Looking For A Career In Criminal Justice?**

The City of BN has been meeting with the St. Louis Community College at Florissant Valley, Department of Criminal Justice. The focus of this partnership is to strengthen police recruitment and the police hiring process in our police department. Key points of this endeavor include police officers in the Florissant Valley College classroom engaging with students, an observation student internship with our police department, proctored testing at the college, and involve-

ment of college staff during interviews. The goal is to establish strong relationships between our police officers and members of our community who are interested in serving as a police officer and familiarizing them with the law enforcement profession. This new and innovative idea will serve as the new model for police recruitment as it increasing the quality of police candidates for hire while engaging members of our own community.

New Emergency Communication System
a \$100 million bond issue, passed • Compliance with federal requirements for public

Proposition E-911, a \$100 million bond issue, passed on the November, 2009 ballot, is finally up and running. Emergency services have started broadcasting on a new, digital trunk system. Proposition E-911 is a one tenth (1/10th) of a cent sales tax that adds one dime to a \$100.00 purchase or one cent on a ten dollar purchase. The new system provides:

- Up-to-date 911 technology so calls from cell phones can be located quickly and reliably.
- Replacement of outdated radio systems for police, firefighters and paramedics.
- A shared set of frequencies so entities can coordinate lifesaving services.

- safety communications.
- An improved emergency siren system that will improve coverage.

One of the most important changes that residents should be aware of is the change of the Non-emergency Dispatch number. The new number, effective **immediately is 636-529-8210**. This number should be used to report suspicious persons, vehicles or activities. Reporting a suspicious person could stop crime by putting police in the area. Please make note of this number and call when you know something is just not right!

**CERT Training** 

Emergencies can strike anytime. A tornado, a flood or even a terrorist attack can change lives. Missouri families, communities, businesses and schools need to take steps today to prepare for an emergency.

The Community Emergency Response Team (CERT) Program educates people about disaster preparedness for hazards which may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. Using

the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help. CERT members are encouraged to support emergency response agencies by taking a more active role in emergency preparedness projects in their community.

#### **Street Repairs - Bond Issue**

In 2009 the voters approved Prop S allowing the city to issue bonds in the value of \$5.5 million dollars. Over the next three years this money was used solely for street repairs, which rebuilt and repaired approximately 40% of the streets. However the remaining 60% have continued to deteriorate, and need to be addressed. The only way that we have to

finance this is with a bond issue.

We are looking at proposing a bond issue to the voters on the November ballot in the value of \$10 million dollars. This money will be used strictly for repair of the remaining streets, which is estimated at \$10.2 million without inflationary increases over the years of the project.

#### Effects of SB # 5

One of the most talked about pieces of legislation from this year's session of the Missouri General Assembly is Senate Bill 5, a law obviously designed to cripple many cities in St. Louis County regardless of the consequences to the residents who rely on them for public safety and services. The law radically limits the fines a court can impose to punish dangerous drivers and wipes out most of the tools available to ensure that those charged with the most traffic violations appear in court to answer those charges.

Fortunately, though we may be put to expense and disruption due to changes mandated by this law, The City of BN will be able to continue to serve our citizens and protect our safety, homes and neighborhoods. Hyped up media stories about "debtor prisons", revenue-oriented municipal courts and "forprofit" policing programs have never applied to The City of BN.

One part of Senate Bill 5 established standards which cities in St. Louis County (but not in the rest of the state) must meet in the next 3 to 6 years. We are pleased to report that our long-standing practices already meet and exceed these criteria. For instance,

our Police Department was among the first departments in the state to be accredited by the Missouri Police Chiefs Association. We attained that distinction long before there was any discussion of requiring accreditation of municipal departments in Missouri. We are proud of the honors our Department has earned and we will continue to maintain the highest levels of performance and accreditation in order to assure our residents of the highest levels of service.

Our municipal court began refining its procedures and adopting new and innovative programs many months ago. We will continue to explore and adopt best practices for court operations just as we constantly do for other programs and services the city offers.

We are confident our community and our safety will not be compromised by the shortsighted anti-city frenzy which carried away so many politicians in Jefferson City this year. We invite you to attend Board of Alderman meetings on the 1st and 3rd Thursdays each month and to call any of your elected officials if you have any questions about how this legislation will affect your neighborhood or how the city will respond. # **Memories Of The Early Days In Bellefontaine**

Mike Benzen recently shared his memories of the City of BN on Facebook, "Bellefontaine Neighbors Then and Now" and agreed to share with us. Here is his post: "My family moved onto Unicorn Drive in August 1952. Southwestern Bell Telephone did not have the capacity to meet the sudden growth in the area. As a result, we and those who moved in around us could not get a telephone. To meet emergency needs, the phone company installed a telephone booth with a coin-operated pay phone on the corner of Tappan and Kilgore. Surprisingly, people gave out the telephone booth phone number to receive calls! The neighbor kids and I would ride our bikes down to the phone booth and play ball until the phone rang. We would answer the phone, then jump on our bike and go notify the person who was to receive the call. Got a lot of tips doing that. In 1952, Southwestern Bell com-

pleted the expansion of the Underhill exchange and we were able to get a phone. Not everyone was happy with the completion of the expansion because we, as kids, lost a very good revenue source."

pounds can be disposed of at a cost to the resident of \$1.00 per pound.

NOTE: Latex paint is not a hazardous material but can be recycled at a cost of \$0.20 per pound.

Missouri Commission on Human Rights (MCHR)

Mayor Doerr, Ms. Deni Donovan and the Bellefontaine Neighbors Human Relations Commission recently met with Dr. Alisa Warren, the Executive Director of the Missouri Commission on Human Rights (MCHR), and Amanda Biondolino, MCHR's Human Rights Attorney, to learn more about the MCHR and how Bellefontaine Neighbors' HRC and MCHR can work together to promote human rights. MCHR is the state agency which enforces the Missouri Human Rights Act. The Missouri Human Rights Act prohibits discrimination in housing, employment and places of public accommodations based on race, color, religion, gender, disability, national origin, ancestry, age and housing.

Have you been told that an apartment for rent is too small for kids? Has your landlord charged you a "pet" deposit to keep a service or support animal required for your disability? Have you been denied service at a restaurant, while people of a different race were served? Were you denied employment because your religious beliefs conflicted with the employer's dress code? If so, you may have experienced discrimination!

MCHR investigates claims of discrimination and will litigate those complaints if it finds probable cause to believe discrimination occurred. Anyone wishing to assert their rights under the Missouri Human Rights Act must file a complaint with MCHR within 180 days of the most recent alleged act of discrimination. MCHR has a work sharing agreement with EEOC and HUD, and complaints filed with MCHR are dually filed with those federal agencies.

MCHR also strives to develop, recommend, and implement ways to prevent and eliminate discrimination before it occurs. The Missouri Commission on Human Rights Training Institute offers training and

education about discrimination in the workplace, places of public accommodations and housing so that Missourians better understand their rights and obligations under the Missouri Human Rights Act. MCHR has trained over 45,000 people on topics such as Diversity, Disability Awareness, Sexual Harassment Prevention, and many more. These training programs assist employers, businesses, housing providers and individuals to work together to create an environment free of discrimination.

Representatives of MCHR will present a complimentary training module to the Bellefontaine Neighbors HRC about the Missouri Human Rights Act and complaint process in September. The goal of the training is to equip the HRC with the knowledge necessary to help residents recognize potential acts of discrimination and how to assert their rights under the law. MCHR will also present the topic of fair housing law at the Diversity Meeting on October 8 at 7:00 PM.

Each year, MCHR hosts an Annual Human Rights Conference to celebrate International Human Rights Day. This year, the conference will take place in St. Louis, Missouri, on November 6, 2015, and is open to anyone interested in learning more about human rights. The cost is \$25 which includes breakfast and lunch.
