
Accepting the award Alderman Anthony Smith, Alderman John Jordan, Mayor Robert Doerr, Chief Jeremy Ihler, and Officer

Furthermore, they gained a better understanding of the core function of policing as it concerns protecting and serving the community.

Overall, the program encouraged young people in the Bellefontaine Neighbors area to become achievers, role models and effective leaders in school, their neighborhoods, and community.

In special observance of her efforts in creating and implementing the Youth Life Skills Recreation Program, the award was dedicated to the memory of BN Officer Peggy Vassallo, who was fatally injured in a car accident on August 24<sup>th</sup>, 2015, while on duty.

#### Major Case Squad

The Greater St. Louis Major Case Squad is the 1st ever and largest task force of it's kind and have a 86% success rate.

The Major Case Squad does not bill municipalities for their services, rather they rely on participation from members. The Major Case Squad only expects municipalities to supply gasoline and food for investigators.

#### C. E. R. T. Training Five North County residents received emergency response training the weekend of September 18-20. CERT is a program within Citizen Corps that trains residents how to cope with the aftermath of a natural disaster while waiting for fire/police/EMS to arrive.

The course is 20 hours in length and was hosted by the Bellefontaine Neighbors Recreation Center and instructed by members of the Riverview Fire Protection District. Thanks to Fire Chief Joe Bommarito and Mayor Bob Doerr for providing the funding to have this class.

### **Snow Routes**

The street department does an amazing job keeping our streets open during snow events. The City of BN has passed ordinances to ensure sufficient space for emergency vehicles to serve residents and snow removal equipment to easily maneuver and clean streets efficiently. Ordinance #2096, passed in 2008, limits parking during snow or ice events on:

- Comet Drive, between Ashbrook and Dwight

- Kelvin Drive, cul-de-sac only
- Kimball Court
- Laire, 1100-1200 block

- Southworth Court
- Surf, 10232, 10236

Ordinance #2314, passed on January 15, 2015, designates Green Acres Road from Bellefontaine Road, generally westward to the "Y" intersection at lot #47, including Orchard Court, Orchard Lane, Willow Court and Willow Lane as no parking snow routes.

### Senior & Disabled Transportation Service

The City of BN is eagerly waiting for a new van for the Senior and Disabled Transportation obtained from a grant from the East West Gateway Coordinating Council. The grant was obtained in 2012, but due to cutbacks in spending, the City of BN has been with other entities on a waiting list.



The van takes residents to medical appointments along the 270 corridor as far as DePaul Hospital, Shop 'n Save, Target, K-mart, Schnucks, Aldi, Post Office, Drug Stores, Hair Salons, Barber shops, and the Recreation Center for classes, activities.

The present vehicles have racked up a lot of miles, but are still road worthy and make life a little better for a lot of people. Residents age 55+ or those with qualifying disabilities are eligible. The van is wheelchair accessable. Residents must purchase an annual ID card at the cost of \$5. There is no cost for trips. #### **Riverview Gardens Scores In Fully Accredited Range**

School Performance Reports, which the Missouri Department of Elementary and Secondary Education released Friday, October 23rd, shows that Riverview Gardens School District (RGSD) earned 79.3 percent of the possible points. Last year, the RGSD earned a score of 45.4 percent on the reports, which incorporate data such as test scores, graduation and attendance rates.

"I couldn't be a more proud superintendent than I am today," said Scott D. Spurgeon, who began in July 2013 leading the RGSD, where part of the focus has been on attendance and curriculum improvements. "I can't tell you what happens from here, other than that we had a very, very, very,



very good year, and we believe we have a really solid system in place to provide a high academic program for our scholars."

The RGSD has asked state officials to shed its unaccredited designation, which allows students to transfer to better-performing schools, because newly released state data showed it made substantial academic gains.

The Missouri State Board of Education will consider districts' accreditation during a December meeting, according to Missouri Education Commissioner Margie Vandeven. She declined to offer specifics about what recommendations would be made. "We are really very cautiously optimistic about what we are seeing," Vandeven said. "Those are great things to see."

### **City Of BN - Open Records**

Ordinance # 1903, was updated and passed August 19, 2004, to reflect current Missouri State Statutes. This legislation is commonly referred to as the Sunshine Law.

Chapter 1 - GENERAL PROVISIONS Sec. 1-21. Meetings, records and votes to be public; exceptions.

All meetings, records and votes are open to the public; except that any meeting, record, minutes or vote relating to one (1) or more of the following shall be closed unless the public governmental body votes to make them public: legal actions, confidential or privileged information protected from disclosure by law, personnel records, computer codes, credit card numbers, etc. For a complete list, refer to the Code of Ordinances. (Ord. No. 1983, §2, 8-19-04)

Sec. 1-32. Fees.

(a) The custodian shall charge ten (10) cents per page for a paper copy not larger than nine by fourteen inches, plus an hourly fee for duplicating time not to exceed the average hourly rate of pay for clerical staff of the City. The St. Louis County Office of Community Development offers NO COST home improvements to keep your children safe. These improvements may include window and door frames, exterior trim enclosures and interior and exterior painting. To qualify, you must meet the following criteria:

- You own a home built before 1978
- You are current on your property taxes
- You have a child under the age of six living in the home or you have a child under the age of six who frequently visits the home.
- You have an adjusted household income that meets HUD guidelines.




### **BN Police Officers Hold Bingo At Veteran's Home**
