## BNPD News & Notes



### Chief Robert Pruett

With the approval of the Mayor and Board of Aldermen, Corporal Peggy Vassallo was promoted to the rank of Sergeant effective November 27, 2011.

Chief Pruett recommended her for promotion based on her outstanding work performance which has been above and beyond the call of duty. Along with her duties as a D.A.R.E. Instructor and Coordinator of the Neighborhood Watch Program, Sgt. Vassallo works with residents in the community to improve quality of life issues and needs.



Two new officers have been hired by the BNPD; one to replace an officer that left the force and one for a newly created position.

## Neighborhood Watch / Neighborhood Ownership

Mike Petetit started a citizen-based crime prevention program in the City of St. Louis' Lafayette Square neighborhood to fight crime. The program is designed to get residents to partner with the law enforcement officials to make neighborhoods safer. The program is working well in the Lafayette Square Neighborhood and other neighborhoods within the City of St. Louis. Citizens that have joined these groups have found that they have more power than they ever thought.

Mike made presentations to Neighborhood Watch and the Board of Aldermen, who approved the program. Plans have been made to put the program in place. The City of BN has the advantage of using this program as a prevention tool and keeping crime down instead of waiting until the criminals have taken over.

The program includes a citizen-based safety patrol; citizens who patrol the city and report suspicious activity, trash littering the streets, street lights that need to be replaced, ordinance violations and any concerns they see. Citizen training takes only about an hour. Citizens are not trained to handle crime, only report what they see to the right authority. Citizens on patrol will not replace police officers.

The program also includes a Victim Support Team. Since many crime victims are afraid to show up in court, many criminals are let go or get light sentences. When victims and a support team of neighbors and friends accompany them to court, it is noticed by the Court and taken more seriously.

Working with the courts, Mike Petetit gained insight to be able to implement, "Neighborhood Orders of

Protection." This is a protection order, keeping offenders who committed crimes in the city, and do not live in the city, out of the city.

## Human Relations Commission

Ordinance # 1127, passed in 1980 was called the Fair Housing Ordinance. It was updated in 1985 and again in 1994, when a three person commission was established to address fair housing practices in the City.

Ordinance # 1980, passed in 2004, changed the commission to a five members and expanded duties, including promoting understanding, eliminating prejudice, improving human relations and investigating discriminatory complaints.

Human Relation Commission members are chosen by the Mayor and approved by the Board of Aldermen for a term of 4 years to run with the term of the Mayor. # Progress Report From The Riverview Gardens School District

## Dr. Clive Coleman

Riverview Gardens School District Superintendent Dr. Clive H. Coleman believes that with parent and community support, all students will become successful, life-long learners competitive in a global society. The philosophy is echoed by teachers and parents. Community members received an update on the District's status at the January 5th meeting of Bellefontaine Neighbors Board of Aldermen.

A cornerstone in the North County community, Riverview Gardens Schools serve students who reside in nine municipalities. The District currently educates 6,000 students in grades Kindergarten through grade 12 at nine elementary schools, two middle schools and one high school. The District also offers an affordable, award winning, accredited Early Childhood Program, dual learning opportunities and several courses that provide college credit.

While the District remains classified as "Unaccredited" by the Missouri Department of Elementary and Secondary Education, "Our data shows progress and improvement in many areas and we continue to strive toward excellence and accreditation," noted Coleman. Gibson Elementary School made Annual Yearly Progress (AYP) last year and more schools are on track to do the same.

One of the major areas of improvement is student attendance. "Without students attending school daily, learning will suffer." The attendance for Riverview Gardens' students is currently 92.5% which is up from 90.25% last year. "Our 2011-2012 goal is to achieve an attendance rate of 95%," reported Coleman "and we are well on our way."

Financially, the District has generated a strong operating fund balance of approximately 36% for the 2011 - 2012 fiscal year, and recently completed its \$15 million Prop R construction initiation on time and within budgeted parameters. Additionally, the District recently refunded (refinanced) \$9.35 million in outstanding debt associated with a Series 2003 General Obligation bond issue at a savings of \$528,000. The District has also experienced an increase in its bond rating in recent years, with the recently refunded bond issue receiving a "AA+" rating from the Standard & Poor's bond rating agency.

The implementation of the Curriculum and Instruction Evaluation and Revision Process has garnered rave

reviews. Annually, administrators and teachers re-evaluate the school-wide results on state and national assessments and determine areas that need to be addressed. Data collected from assessments, parents, teachers and administrators is considered as well as changes in state and national standards, critical issues in the content area, and new developments in educational pedagogy. The result is a rigorous curriculum adaptable to the needs of students at all grade levels.

Riverview Gardens School District regards professional development as a fundamental responsibility for all staff. Support is provided to educators in their continual efforts to improve instruction so that each student may achieve at higher levels. Recently the District adopted "Late Start Wednesdays" which provide teachers weekly professional development opportunities aimed at achieving Missouri School Improvement Plan goals. New teachers are also provided a Teacher Mentor which gives them professional support and guidance from experienced educators.

In 2011, Riverview Gardens School District students received more than \$2.7 million in scholarships. Of the 348 graduates, 229 were accepted into Post-Secondary Schools and numbers are projected to increase this year. The graduation rate was improved from 67% before the District lapsed to 81% last year. Recently, the Riverview Gardens High School hosted an event aimed at providing students and parents assistance with completing financial aid information online. The FAFSA Frenzy, served over 120 families providing each with financial aid tips and scholarship information. "The event will help encourage students to apply to college by removing the financial barrier which may seem insurmountable," noted Coleman.

Improvements and much needed upgrades were completed this year with Proposition R funds. Completed on time and within budget, renovations to school buildings helped create a safe environment conducive for academic achievement. The benefits enjoyed by students and staff from Prop R improvements are vast and long lasting.

The Riverview Gardens School District continues to make strides and with community support will develop responsible citizens who are globally competitive. ## Street, Coburg Lands, Belgrove & St. Cyr Improvements

Street repairs made possible by the \$5,500,000 bond issue passed in 2009, will be winding down this year. Street repairs on Siebe, Angeline and Haviland Drive are scheduled to begin in the spring and be finished this summer. At that time we expect the remaining \$160,000 in funds to be depleted.

The East-West Gateway Coordinating Council has approved grants from Missouri Highways and Transportation totaling \$1,246,000 for connector and high traffic streets in our city.

Coburg Lands, from Chambers Road to Bellefontaine Road will be overlaid and sidewalks will be upgraded to American Disability Act Standards. Belgrove Drive will be overlaid from Bellefontaine Road to Lilac Drive.

Total cost of this project will be \$607,000. The City of BN will pay \$121,400. Construction is expected in the summer of 2013.

St. Cyr Road from Bellefontaine Road to the Village of Riverview City limits will be repaired and the bridge, estimated to have been built prior to 1930, will be replaced. The total cost for this project is \$950,000. The City's cost will be \$190,000 and this project will be scheduled for summer, 2014. The City of BN will be exploring options to work with Great Rivers Greenway and other entities to make St. Cyr Road a link from the path at Bella Fontaine Park to the Riverfront Trail.

More grants will be explored to repair more streets in the City of BN.

**Absentee Vote Information** Applications to obtain an absentee ballot are available at City Hall, the St. Louis County Election Board or on the internet. Applications must be received by the election board before March 28, 2012. Anyone who is unable to go to the polls due to physical limitations may vote by absentee ballot and a notary is not necessary. Ballots will be notarized free of charge at City Hall during regular office hours.

**Transportation To The Polls** Anyone needing a ride to the polls on election day may get a ride on the BN Bus. Call the Recreation Center ASAP at 867-0700 to make arrangements.

## Dangerous Animals

The City of BN allows Pit Bull breed dogs and other dangerous animals under restricted conditions. Owners of dangerous animals must register the animal with the city, show proof of rabies vaccination and \$100,000 insurance policy, provide a covered dog run, post signs, use a muzzle and leash at all times when not in a pen and other restrictions. For more detailed restrictions, call City Hall. (Ordinance # 1497)



If you have a serious problem with an animal in your neighborhood, please call the City Hall at 867-0076 to make a complaint.

The City of BN takes dangerous animals seriously and looks into complaints made about animals. The City of BN will investigate the complaint and take appropriate action.

Any animal, regardless of breed can be deemed a dangerous animal by the police Department.

The City of BN will be holding the annual Dog and Cat Vaccination Clinic on Saturday, June 2. Please mark your calendars.

## Waste Management Cart Placement Guidelines

Since Waste Management has gone to an automated system, they are asking for our help to make collection more efficient. Here is how you can help:

- Yard waste, garbage and recycling carts should be at least three (3) feet apart.
- Carts should be within eighteen (18) inches of the curb and the short metal bar must face the street.
- Do not place cart near low-hanging branches, cars mail boxes or shrubbery.
- The lid of the cart must be closed to prevent spillage into your yard or the street.



**INCORRECT:** Carts placed too close together cannot be picked up using the automated arms of the truck. This slows down collection, takes more effort of the driver and uses more fuel.

**CORRECT:** Carts placed 3 (three) feet or more apart with no obstructions allow drivers to use automated system efficiently and saves time, effort and fuel.

### Ordinance Violations - Leaves & Yard Waste



The Building Department has avoided sending letters in mass for ordinance violations regarding leaves accumulating in yards and are just responding to specific complaints called into City Hall. However, beginning March 1, warning letters or tickets will be issued to anyone who has accumulated leaves, fallen branches and debris. Please take advantage of the warmer days by taking time to clean up your yard.

Our contract with Waste Management provides every home with 1 trash cart and 1 yard waste cart at no extra cost. If you don't have a trash or yard waste cart, call Waste Management at 506-4700, tell them you want a cart and it will be delivered to your home. Yard Waste is picked up year round. The carts are easy to handle and eliminate the costs of yard waste bags. Recycling carts are available from City Hall at 867-0076.

### The Audubon Center At Riverlands



The St. Louis District of the Corps of Engineers and Audubon Missouri have been working together to fund, staff and provide programs for a new facility on Highway 367, just South of the Clark Bridge to Alton, Illinois. The new facility opened October 15, 2011.

The Audubon Center at Riverlands will offer world-class birding, education and

outdoor opportunities along one of the most significant migratory flyways on earth; the Mississippi River. The Center is expected to attract national attention and serve as an economic driver for the region. Free programs for children and adults are available. 


## Storage Trailers, PODS, Dumpsters & Bagsters

The Board of Aldermen passed Ordinance # 2201 regulating the parking and placement of storage trailers, portable on demand storage units (PODS), dumpsters, including soft-sided dumpsters, Bagsters and other similar devices on November 17, 2011. This ordinance was passed to preserve our neighborhoods, insure the health, safety, and welfare of the City's residents. The following restrictions apply;

- Storage trailers, PODS, dumpsters, Bagsters and other similar devices cannot be parked on any street, highway, roadway, fire lane or sidewalk.

- Storage trailers, PODS, dumpsters, Bagsters and other similar devices must be placed on a durably paved surface such as concrete or asphalt and shall be



situated to minimize the potential of interference with sight lines for motorists on adjoining streets and nearby drive ways.

- Permits are required for all storage trailers, PODS, dumpsters, Bagsters or other similar devices by the City Engineer. Cost of the permit is \$25.00 and expires in 30 days. No more than two permits may be issued for any lot or parcel of property in a twelve (12) month period. Bright orange permit cards shall be displayed in the window of the property.

Provisions have been made that in case of natural disasters or special circumstances, the City Engineer shall have the authority to waive restrictions. For more information, Call 867-0076.

## Building Department User Fees

The Board of Aldermen passed Ordinance # 2203 on December 1, 2011. This is the first time Building Department user fees have been raised in 17 years.

The ordinance was passed to address the increase of costs of processing permits by the Building Department and office personnel, increases in notices put in newspapers, inspections, fuel and salaries. Increases do not reflect the entire cost of the permits, but split the costs between the city and applicants.

Permits for new buildings, additions, residential storage sheds and accessory buildings were previously \$30.00 for the first \$1,000 of building cost and an additional \$3.50 for each additional \$1,000 of building costs. New permit fees will be \$50 for the first \$1,000 of building costs and an additional \$3.75 for each additional \$1,000.


