

### From The Office Of The Mayor



The November issue of the Bellefontaine News is being delivered early so we can get you information about issues on the November 3, 2009 ballot. There will be three propositions for voters to decide: A Bond Issue (Proposition R) for the Riverview Gardens School District, The Prohibition of Smoking (Proposition N) in St. Louis County

and a Bond Issue for Emergency Communications (Proposition E-911) for St. Louis County.

Proposition E-911 is of special importance to our city. If the proposition fails, the City of BN will be forced to finance a new communications system and replace all of our police radios by the year 2012. Please read the information about Proposition E-911 on page 3.

Crews are working on replacing failed concrete slabs and preparing the streets for new asphalt. See page 8 for more information. We expect Phase 2 to get started in March of 2010 and the Shepley Bridge Project is scheduled for Summer, 2010.

AmerenUE has completed Phase 1 of the underground cable program. Phase 2 is estimated to be completed in December, 2009. We hope to see more work scheduled for 2010.

Through a contract with Insituform Technologies, MSD is spending \$4.5 million to rehabilitate over 64,000 feet of sewers in and around The City of BN. The work is about 50% done and is slated to be completed in January 2010. The method that is being used is

called "cured in place pipe," where a resin-saturated felt tube made of polyester is pulled through the damaged sewer pipe. Little to no digging is involved in this process, minimizing the inconvenience for residents. Watch for flyers and lawn signs alerting you to when this work will be done in your neighborhood. ### Issues On The November 3, 2009 Ballot

ST. LOUIS COUNTY - **PROPOSITION E-911** SIMPLE MAJORITY REQUIRED

Shall St. Louis County establish an emergency communications system fund to establish, operate and maintain an emergency communications system and for which St. Louis County shall levy a sales tax of one-tenth of one percent, to be paid into the fund for that purpose?

#### ST. LOUIS COUNTY - **PROPOSITION N** SIMPLE MAJORITY REQUIRED

Shall the Revised Ordinances of St. Louis County be amended by enacting and adding thereto a prohibition of smoking in enclosed public places in St. Louis County, all as set forth in Exhibit A of Ordinance No. 24,105 on file with the St. Louis County Administrative Director and the St. Louis County Board of Election Commissioners?

#### RIVERVIEW GARDENS SCHOOL DISTRICT, PROPOSITION R

FOUR-SEVENTHS MAJORITY REQUIRED Shall the Board of Education of the School District of Riverview Gardens, St. Louis County, Missouri borrow money in the amount of fifteen million dollars (\$15,000,000) for the purpose of acquiring, constructing, renovating, expanding, improving, furnishing and equipping school sites, buildings and related facilities for school purposes and issue general obligation bonds for the payment thereof, resulting in an estimated increase to the debt service property tax levy of \$-0- per one hundred dollars of assessed valuation? If this proposition is approved, the adjusted debt service levy of the school district is estimated to remain unchanged from the current debt service levy of \$1.01 per one hundred dollars assessed valuation of real and personal property.

### Polls Will Be Open 6 AM To 7 PM

If you are unable to get to the polls on November 3, you can cast an absentee ballot. Request forms for absentee ballots are available at City Hall or on the internet at: www.stlco.com/Elections/absentee/ absenteeapplication.pdf

If you are out of town on Election Day, you will need your absentee ballot notarized. City Hall and most banks will notarize the ballots for free. If you are unable to get to the polls due to physical limitations or illness, a notary is not necessary.

Absentee ballot requests must be in the election office by 5 PM on Wed, October 28 to be accepted.

Voters may also vote in person at the Election Board,

12 Sunnen Drive, Maplewood, MO 63143, during regular business hours from September 22 to November 2, and on Saturday, October 31 from 9 AM to 1 PM. You can contact the Election Board at 615-1833.

Transportation to the polls is available through the Recreation Center, Senior Bus Service. Please call 867-0700 in advance to schedule a ride to the polls.

Please remember to check your voter notification Cards for locations of polling places.

In order to vote in the November election, residents have to be registered before October 7, 2009. Residents may stop by City Hall, any school or public library to register for future elections.

## Filing For Municipal Election, April 6, 2009

Residents who are interested in filing for the office of Alderman, City of BN, may file as candidates beginning Tuesday, December 15, 2009 through Tuesday, January 20, 2010 between the hours of 8 AM to 5 PM. One seat is up for election in each ward. Candidate qualifications: 21 years old, US citizen, an inhabitant and resident of the city for at least one year preceding his/her election, and a resident, at the time he/she files and during the time he/she serves, of the ward from which he/she is elected. Your position on the ballot will be determined by a lottery on the first day and as you file after the first day. For information call the City Clerk at 867-0076.

The Riverview Gardens School District and Hazlewood School District will have positions on the ballot, also. For information on these positions, please call the school districts. ## **Proposition E-911**

The Federal Communications Commission has issued new requirements for Fire Departments and Police Departments for the year 2012. As a result of the new requirements, county-wide Proposition E-911 will be on the November 3, 2009 ballot.

There are 66 police departments and 43 fire agencies in the St. Louis County. Each entity could invest taxpayer dollars in new radios, but these systems would still be incompatible, they still would not be able to trace emergency cell phone calls and the county siren system would still be unreliable. The Emergency Communications Commission has indicated that by working county wide, the result would be a cost-effective system that is fully compatible, facilitating the coordination of mutual aid and emergency services in times of need, such as major disasters.

Here is what proposition E-911 will provide:

• **Up-to-date 911 technology** so that individuals placing emergency phone calls from their cell phones can be located quickly and reliably.

• **Replacement of outdated radio systems** that police, firefighters and paramedics rely on to protect all St. Louis County citizens - those living in munici-

### Mayor And Board of Aldermen Endorse Proposition E-911

The Board of Aldermen passed Resolution 2009-3 endorsing Proposition E-911 on September 3, 2009. The Resolution reads (in part): "NOW THEREFORE IT BE RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF BELLE-FONTAINE NEIGHBORS, MISSOURI, AS FOLLOWS:

The Board of Aldermen of the City of Bellefontaine Neighbors does hereby support a modest sales tax increase of 1/10 of 1 percent, equating to a dime on each \$100 purchase, in order to improve all aspects palities and unincorporated St. Louis County.

• A shared set of frequencies so that in times of emergency they can better coordinate lifesaving services through a compatible system.

• **Compliance with federal requirements** that all public safety communications improve their radio frequencies in 2012.


• An improved emergency siren system that will imporve coverage and performance so that the sirens protect all of St. Louis County.

Proposition E-911 will generate \$16 million annually. These funds would be used to pay off a \$100 million bond issue for system capital costs, plus provide funds for ongoing operations, maintenance and reserves. According to the Emergency Communications Commission's analysis, working countywide will enable these improvements to be made more cost-effectively than if each public entity worked alone to meet the FCC's new requirements.

Proposition E-911 is a one tenth (1/10th) of a cent sales tax that would add one dime to a \$100.00 purchase or one cent on a ten dollar purchase. This is a small price to pay for better communications.

of the emergency communications system serving all agencies in the St. Louis County in order to enhance the safety, response time, and coordination of our first responders and shield our citizens when in harms way and urges Bellefontaine Neighbors residents and St. Louis County voters generally to educate themselves on the issue and vote in favor of Proposition E-911 on November 3, 2009."

### **Recycling Carts**



Through a grant from St. Louis County, The City of BN will begin delivering 65 gallon recycling bins to homes during the first week of December. The bins will be green with yellow lids and are to be used only for the purpose of recycling.

With the expanded list of recycling materials, residents are finding their trash dwindling and their

recycling bins fuller. Residents can now recycle almost all plastics, metals, glass and paper, in fact, with the new lists of recyclable material, 70% of your trash can be recycled. By reducing our trash and increasing recycling, we are saving natural resources, energy, clean air and water, landfill space and money.

As always, the recycling bins should be put out on your regular day for trash service along with your trash and yard waste. Please place all bins at the street with the back or handle part of the cart away from the street so the automatic arm can pick up the cart.

When the recycling programs started, they were very limited on what they could take. Milk jugs, tin cans and newspaper were about it and they had to be separated at the curb. Now the list of recyclable materials has grown. Most plastic bottles and containers, clean aluminum cans, trays and foil, steel cans and tins, glass and all types of paper including cake boxes, frozen food boxes and even junk mail can be put in the recycling bin and they do not have to be separated.

Check out the list and try recycling. It's good for the planet and your wallet!

#### **Recycling Guide**

**Plastics** - Check the bottom of plastic bottles and containers for a small triangle with a number in it. Items with numbers from 1 to 5 and 7 are recyclable. Please rinse out all food or products



and remove the label if possible. These items include plastic bottles, plastic milk and juice jugs, detergent and fabric softener containers, health/beauty aids, household cleaner containers, margarine tubs, frozen dessert cups, 6 pack rings, yogurt cups, narrow neck syrup and ketchup bottles, and plastic buckets under 5 gallons.

**Metals** - include rinsed aluminum cans, trays, foil, steel cans and tins.

Glass - Clear, brown and green glass.

**Paper** - includes all paper, newspaper including inserts (remove plastic sleeves), cardboard, kraft, brown paper bags, magazines, catalogs, telephone books, paperback books, junk mail and envelopes, office and computer paper, notebook paper, gift wrap, cereal, cake, food mix boxes, frozen food boxes, kleenex boxes, bath tissue rolls, gift boxes, carrier stock, or soda and beer can carrying cases.

The list of items that **cannot** be recycled is much shorter. These items include items with a triangle with a number 6 and includes egg cartons, foam trays, protective packaging. Do not recycle containers that were used for



poison or engine oil. No window glass, dinnerware or ceramics. No plastic grocery bags. Waxed cardboard (fruit boxes) not accepted.

### **Returning Unwanted Recycling Carts Or Totes**

The Mayor and Board of Aldermen of the City of BN encourage you to recycle. If you would like to return the smaller, old recycling bins or you decide you don't want the new recycling cart and would rather use the old bin, you can return either or both of them.

If you do not want the new recycling cart delivered to , please call City Hall at 867-0067 before Nov. 25.

To return bins or carts, please leave them at the curb,

turned upside down, on your regular trash day during the week of December 7th to the 10th.

Recycling the recycling bins is a good idea and will give someone else the chance to recycle. If you miss this round of collection, it will be offered again in the Spring. Please give recycling a try before returning the bins or declining the cart.

There is not a discount if you turn in the bin or cart.

### **Letters Of Commendation From The Chief**



Det. Shawn Applegate

Det. Shawn Applegate assumed the additional work load of Grant - Writer for the Police Department. To date, he has written three grants: **COPS Universal Hiring Grant** to hire four (4) new police officers at no cost to the city for three (3) years in the amount

of \$661,824.00. We are currently on a waiting list for these funds. **A Byrnes Law Enforcement Block Grant** in the amount of \$36,000.00 to purchase and equip a marked police vehicle at no cost to the city. Most recently Det. Applegate wrote a **Local Law Enforcement Block Grant** to purchase safety equipment for officers during civil unrest. This grant totaled \$12,436.00 with 72% or \$9,000 paid by the Federal/ State Share and 28% or \$3,426 paid by the city.



#### P.O. Jeremy Johnson

In August of 2009 officers responded to a call for an Assault with a Weapon, believed to be a handgun, in the 1100 block of St. Cyr Rd. near Danforth School. The officers initial investigation provided contacts and leads,

some of which lead to the Riverview Gardens High School. Officer Jeremy Johnson, who is assigned as the School Resource Officer, was made aware of the incident and was provided the initial investigative information. Officer Johnson was able to gather leads from various contacts. P.O. Johnson identified and detained a possible suspect. Working with a Family Court investigator, the suspect was interrogated and the juvenile suspect was charged with Unlawful Use of a Weapon, Assault 3rd, and Peace Disturbance. The weapon, a starter pistol, was recovered.



#### Cpl. Peggy Vassallo

As a result of numerous resident complaints Cpl. Peggy Vassallo began speaking with the mother of a young man about her son receiving a mental evaluation and treatment. With the cooperation of the mother, an affidavit requesting a mental evaluation was completed. Without receiving the complete evaluations, the young man was released. Within 3 hours of his release, the Police Department was called and the young man was arrested for an indecent act. Using her (CIT) Crisis Intervention Training, Cpl. Vassallo called numerous resources to obtain help. Her due diligence paid off with the young man being placed in a mental health facility where he will receive long term care, and allows the neighborhood residents to live in a much more peaceful community.

In September of 2009 Officer Dane Kaltenbach and Corporal Jason Hagan responded to a call for a shooting in the 10100 block of Ashbrook. The officers conducted the initial investigation, gathered physical evidence, information and witnesses that built a profile of the suspect.

Lt. Thomas Sheehan and Det. Shawn Applegate, assigned to the Bureau of Investigation, gathered additional information that ultimately lead to the suspect vehicle. Utilizing the vehicle information, the Detectives identified a possible suspect. The detectives showed the witnesses and victim a photo line-up of the vehicle and suspect. The vehicle and suspect were positively identified and a wanted was entered.

Cpl. Timothy Sanders observed the suspect vehicle parked in front of the suspect's home and immediately requested the assistance of members of the "B" Platoon. The suspect was arrested without incident. The arrest culminated in felony warrants being issued on the suspect for Assault 1st Degree and Armed Criminal Action with a cash only bond of \$100,000. ### **Snow Removal And Snow Routes**

In December of 2008, The Board of Aldermen established "Snow Routes" to insure emergency vehicles have ready access to all streets at all times for the health, safety and well being of city residents. This

ordinance makes it a violation to park on streets that are narrow, heavily traveled or steep and have been posted with "No Parking On Snow Days" signs when there is a prediction of two (2) inches or more and an emergency has been declared. Your vehicle could be towed at your expense and you could be fined for parking on designated snow routes.

Keep in mind that the snow plows are 9 feet wide and need room to navigate and clean your streets. When vehicles are parked in the street, the city's ability to remove accumulated snow and ice is limited.

You can help even if you don't live along a snow route and your benefit will be cleaner, easier to navigate streets. Park your vehicles in your driveway whenever possible. If you don't have a vehicle, offer your driveway to a neighbor who has too many vehicles for their driveway. It makes your home look "lived-in" and it makes snow removal easier, too.

### **Street Repairs - 2009**

Construction crews began work on our streets early in October. The first order of business was to remove the sections of concrete that had failed over the years. In some places, small areas at the curb were replaced and in other area whole sections of the street were replaced. Some streets require mud-jacking.

After the concrete is replaced, crews will mill down the old asphalt and put a new asphalt layer over the concrete streets.

Work is expected to continue as weather permits.

The Phase 2 work should begin next spring and take four to five months to complete. The Shepley Road Bridge Project should begin next summer when school is not in session.

Please drive carefully in construction areas.



With the winter months approaching, I would like everyone to remember now is the time to have your furnace checked out to ensure proper operation. Changing the furnace filter regularly as well as a furnace in good running order will operate more fuel efficiently, which relates to a savings on your fuel bill.

Please remember, as you prepare to decorate your house for the Christmas Season, if you must use extension cords use only a cord that is rated for exterior use. Not all extension cords are rated for exterior usage and using the improper extension cord can cause a fire. Also, remember that our electrical circuits are only rated to carry a designated load. If you overload a circuit you can blow a fuse or trip a circuit breaker. This can also be dangerous to the wiring in your home.

Don't forget to check your smoke detector batteries regularly and change the batteries at least every six months. Remember the quote "Change Your Clock, Change Your Smoke Detector Battery". (November 1 is when Daylight Savings Time ends.) If you need help changing your batteries please call the fire house (867-3889) and someone will come by to assist you.

St. Louis County will host the Fall 2009 Household Chemical Collection Event on Saturday, November 21 at the Florissant Valley Community College, 3400 Pershall Rd, Ferguson, MO 63135 from 8 AM to 3 PM.

Acceptable Materials: Paints, stains, varnishes, pesticides, poisons, gasoline and other fuels, solvents and strippers, aerosols, motor oil and filters, gas cylinders (BBQ Pit size or smaller), fluorescent tubes, rechargeable batteries, antifreeze, brake and transmission fluid, pool chemicals and other acids and bases, car batteries, wood preservatives, driveway sealant, and items containing mercury (such as thermometers, thermostats and mercuric salts).

Unacceptable Items: Explosives, ammunition, radioactive waste, smoke detectors, medical waste, household trash, tires, electronics and other bulky items. Materials from businesses and from commercial, not -for-profit governmental organizations are prohibited.

Directions: Enter the Florissant Valley Community Campus from Pershall Road, just east of I-270 and Elizabeth Avenue. Follow signs to the drop-off location.
