FireWorks Are Prohibited

Code of Ordinances, ARTICLE I. FIREWORKS Sec. 10-1.

(a) It shall be unlawful for any person to sell, offer for sale, expose for sale or to use, discharge or explode within the city any firecrackers, Roman candles, blank cartridges, toy pistols, toy cannons or canes in which explosives are used, balloons firing from underneath to propel the same, torpedoes, sky rockets, aerial salutes, bombs or other fireworks of any kind.

BNPD And Citizen Awards

Certificates of Commendation presented to:
Officer Michael Pedroli for his professionalism,



performance, commitment, and active quality law enforcement efforts. On April 17, 2016, Officer Pedroli, along with other police officers, were dispatched to the 9500 block of Bellefontaine Road, for a report of gunshots fired. During the investigation, Officer Pedroli chased an armed gunman, took

him into custody, and recovered the weapon. It was determined that the gunman and another suspect had shot a person prior to the police arriving in the area. Officer Pedroli made two arrests pursuant to the incident which led to two charges of Assault 1st and two charges of Armed Criminal Action.

And, a second Certificate of Commendation was presented to Officer Michael Pedroli for his professionalism, performance, active quality law enforcement efforts, and positive impact on crime. On June 7, 2016, an armed gunman committed a carjacking within the City of Jennings. While using the specific description of the suspect and vehicle provided by dispatch, Officer Pedroli conducted a patrol search and located them in the area of Jennings Station Road and Lewis and Clark Boulevard. Officer Pedroli followed the vehicle in an attempt to stop it. During the course of events, the armed gunman left the vehicle and ran. Officer Pedroli chased the suspect, took him into custody, and recovered the weapon. The St. Louis County Police Department charged the suspect for his crimes.

Certificate of Commendation for Life Saving presented to Officer Dennis Lederer for his

exceptional performance of saving a person's life. On August 25, 2016, Officer Lederer was dispatched to the 9300 block of Bellefontaine Road regarding a person not breathing. Dispatch advised that the person was possibly deceased. When Officer Lederer arrived, he located the person, lying



on the floor unresponsive and administered CPR. When the fire department arrived, they administered a defibrillator and she was transported by ambulance to the hospital for further evaluation and medical treatment, which saved her life.

Citizen Citation Award presented to Barbara Carter On April 6, 2016, Barbara Carter observed an unfamiliar vehicle parked in her neighbor's driveway. Ms. Carter also observed unfamiliar people carrying property from inside the home and loading it into the rear of the vehicle. She promptly called the police to report the suspicious activities. After the police had arrived, it was determined that the unfamiliar people had forced their way into the home and were committing a burglary. All suspects were arrested and the victim's valuables were recovered. The suspects were charged with Burglary 2nd, Felony Stealing, and Destruction of Property. The community is a safer place thanks to Ms. Carter's alertness and quick action.

Citizen Citation Award presented to Marquasha Pryor, Andre Holmes, Kevona Ivory, Darryl Criddle, Demonte Hobbs, and Antwaun Williams. On July 19, 2016, at approximately 4:15 PM, the shooting of two elderly people occurred in the 10000 block of Lewis and Clark Blvd. The violent act left

both people critically wounded. The suspect also stole items from the store and then left the area. Working with police, witnesses provided



a detailed description of the suspect along with other information and evidence that was essential to the investigation. As a result, the suspect was identified, arrested, and charged with two counts of Assault 1st, two counts of Armed Criminal Action, and Robbery 1st. This demonstrates how citizens and police work together in an effective and efficient effort to swiftly bring justice to those who are victimized.

Citizen Citation Award presented to Donnie Lee Word, Jr., Reggie Anthony, Shane Swartz, Jason Ingram and Reginald Rohr. On June 15, 2016, at approximately 3:00 Citizen Citation Award presented 3 PM, a roll-over vehicle crash occurred in the 10600 block of Lewis and Clark Boulevard. The crash

involved a head-on collision between two vehicles, to which one of the vehicles left the roadway and overturned. Several



passers by stopped to render aid to the police investigation and victims of the crash. During the course of events, brute strength and force of will by several people present were used to turn the vehicle back over. Both victim's of the crash suffered injuries and were transported by ambulance to the hospital for evaluation and medical treatment. People caring for people is the core of our community strength.

City Of BN Officers Honored By Village Of Riverview

City of BN police officers were called to assist the Village of Riverview police officers on a call for a man that was barricaded in a home and flourishing a gun out the windows. The officers secured the area and took up positions around the home. An elderly woman, who was later identified as

the suspect's grandmother, was escorted out of the house and taken away for her safety. Thanks to the grandmother, officers were able to establish contact with the subject who was barricaded. Officers were able to convince the subject to comply and exit the residence without incident. This incident had the elements to turn into a far worse situation but due to the quick response and professionalism displayed by these officers, this incident resulted in the arrest of an armed subject and no harm or injuries came to anyone involved.

Sergeant Jason Groves from the Village of Riverview, presented a Service Award for exceptional performance of duty to Sergeant Spieler, Corporal Piektowski, Officer Kuechenmeister, and Officer Lederer.


What Is Happening At Mathews-Dickey?

Street Repairs & Bond Issue

Voters in the City of BN passed "Proposition S" for street repairs on August 2, 2016. Proposition S approved eight million dollars for the purpose of street repairs. Since the bond issue passed, the city has been busy with engineering, financing and getting together bid packages. Bids have been recieved and Aldermen are expected to approve the following on Thursday, May 4 at the Board of Aldermen Meeting:

In order to get the most out of the money spent and getting the work done by the end of the year, the City will be divided in half. Although it is not the City's intention to profit from vehicles parked on the street obstructing construction, vehicles may be ticketed or towed at your expense, so construction can continue.

Curfew Ordinance

Reminder to parents - A curfew is in effect for children under the age of 17. Please read the Curfew Ordinance below and be aware.

Chapter 16, Article II - Curfew

Sec. 16-16

- (a) It shall be unlawful for children under the age of seventeen (17) years, of either sex, to be on or about the streets, highways, sidewalks or public places of the city between 11:55 p.m. and 6:00 a.m. on Friday and Saturday nights and between 10:55 p.m. and 6:00 a.m. on all other nights of the week, unless in bona fide search of a physician or unless accompanied by their parent, legally appointed guardian or other authorized adult custodian of such minors.
- (b) The provisions of this section shall not apply to any minor having a permit issued by the police department of the city authorizing him to be upon the public streets, highways, sidewalks and in public places of the city during such hours for legitimate purposes.

Sec. 16-17 Responsibility of parents, guardians, etc. No parent, guardian or other persons having legal

custody of a child under the age of seventeen (17) years shall allow or permit such child to be on or about the streets, highways, sidewalks or other public places of the city between the hours prohibited in section 16-16 unless accompanied by such parent, guardian or other person having legal custody of such minor child or unless such minor child shall fall within the exceptions provided by section 16-16.

Sec. 16-18 Penalties.

If any child is found violating any of the provisions of section 16-16, a warning notice shall be given to the parent, guardian or other person having legal custody of such child. Thereafter, any such child or the parent, guardian or person having legal custody thereof shall be deemed to be guilty of a violation of this article after the second infraction or violation of section 16-16, in which event such parent, guardian or persons having legal custody of such minor child or children shall be subject to punishment as provided in section 1-10 of this Code, and such minor child shall be arrested and turned over to the juvenile authorities of the county for prosecution for violation of this article in accordance with the laws of the state.

City of BN ordinances require dogs and cats have current rabies tags. The city provides an opportunity to get vaccinations and tags at reduced costs at the Annual Dog & Cat Vaccination Clinic. The attending Veterinarian is Dr. Dan Wendt, DVM, who owns and operates the Ferguson Animal Clinic at 843 Airport Road. You can get a discount by showing a spay or neuter certificate.

City ordinances also require that dogs and cats have a City of BN license. The cost of the license is \$2 and can be purchased at the clinic when you get the shots or at City Hall during regular hours by showing proof of rabies vaccination.
