**MEETING WAS CALLED TO ORDER BY** Mayor Pierson at 7:30 p.m. Copies of all ordinances and resolutions to be considered at the meeting were made available for public inspection prior to the time of consideration by the Board of Aldermen.

PLEDGE OF ALLEGIANCE TO THE FLAG was led by Mayor Pierson, Sr.

ROLL CALL: City Clerk called the roll and all members were present except City Attorney.

**APPROVAL OF THE AGENDA:** Motion to amend the agenda by removing agenda line items 4(b) appoint Greg White and 4(c) appoint Clarence Wilson (both to Planning and Zoning) made by Alderman Jordan seconded by Alderman Christian. Motion carries.

Motion to approve agenda as amended made by Alderwoman Avant-Elliott seconded by Alderwoman West. Motion carries.

**APPOINTMENTS:** Mayor asked for a motion to appoint Anthony Gray as City Attorney. There was no motion, therefore Mayor appointed Helmut Starr as Acting City Attorney. Point was made that Attorney Starr will serve under same terms as prior city attorney. Helmut Starr took his seat at the dais.

**SWEARING IN – SAMUEL SIMRIL – WARD 2 ALDERMAN**: Sworn in by City Clerk. Samuel Simril took his seat at the dais.

## PRESENTATION OF THE UNAPPROVED MINUTES:

Motion to approve Regular Board Meeting Unapproved Minutes of June 20, 2019 as amended made by Alderwoman Avant-Elliott, seconded by Alderman Jordan. Motion carries.

Motion to approve Regular Board Meeting Minutes of August 15, 2019 made by Alderwoman Dailes seconded by Alderman Jordan. Motion carries.

**MEETING OPEN TO THE PUBLIC:** The meeting was opened to the public to speak 3 minutes each. **Wanda Lane, 99XX Martingale:** Asked the Mayor if his daughter was the Judge's daughter in law. Mayor answered that Judge Draper is not known to his family and is not related in any way. Has RGSD been invited to the Town Hall Meeting and is the Police Department fully staffed. Mayor will make sure the RGSD Superintendent gets an invitation to the Town Hall Meeting. Chief answered that the police department has 29 of 31 authorized officers.

**PUBLIC SAFETY COMMITTEE:** Alderwoman Tatman reported in leu of the chairman. They had a fabulous meeting with new residents in attendance. Two initiatives brought forth (1) The CERT Program and (2) Ordinances to present, both will have more information forthcoming. Also, Hearts Behind The Badges was great. Alderman Jordan asked Alderwoman Dailes about the goals and information regarding the restructuring of the Youth Commission.
