Motion to amend prior motion from Alderman Carroll to state for Helmut Starr to serve as the board of aldermen's consulting attorney for matters to be determined by the Board of Alderpersons made by Alderwoman Avant-Elliott seconded by Alderman Carroll. Votes are as follows: Alderwoman West-yes, Alderwoman Tatman-no, Alderwoman Reed-yes, Alderman Carroll-yes, Alderman Thomas-no, Alderman Christian-yes, Alderwoman Dailes-no, Alderwoman Avant-Elliott-yes. Mayor stated he is in protest of this action. Motion passed with 5-3 vote.

e. APPROVAL OF BIDS FOR BARRIERS – There was no action on this matter.
