Your vote is important and I encourage everyone to vote in every election.

On April 5, 2011, voters will put an elected County Assessor in place for the first time. Voters will also

elect a new, part time Mayor for the City of Bellefontaine Neighbors (City of BN), and Directors for school districts and fire districts. Polling places will be open from 6 AM to 7 PM. March 9, 2011, is the last day to register to be able to vote in the April election.

St. Louis County residents who are unable to get to the polls due to illness or absence from St. Louis County on election day, can vote by absentee ballot. Absentee ballot applications are available from City Hall (867-0076) and the Election Board (615-1933). Absentee voting will begin on February 22 and the last day absentee applications will be accepted is March 30. Absentee ballots will be accepted through April 4.

If you need a ride to the polls, call the Recreation Center at 867-0700. Please make your reservation in advance so you are guaranteed a ride.

### Gina Walsh Honored For Service To Community

The City of BN chose January 20, 2011, the biggest snow day of the year, to invite former State Representative Gina Walsh, her family and friends, to a Board Meeting to thank her for her service to the community.

Mayor Rudloff presented a Proclamation from the City of BN citing Gina's 8 years in the Missouri House of Representatives, and nearly 10 years as a Director on the Riverview Fire Protection Protection District Board and many years in community and church.

Also present that evening was State Senator Timothy Green, who remembered how Gina hesitated when first asked to run for the position more than 8 years ago. Senator Green told the audience Gina was a pleasure to work with and he would miss her; he presented Gina with a Courtesy Resolution. Representing U.S. Senator Claire McCaskill's office was Mattie Moore, Deputy Director. She presented Gina with a letter from the Senator thanking Gina for her efforts.

Thanks were also offered by County Executive Charlie Dooley, County Councilman Mike O'Mara, State Representative Tommie Pierson and Chief Joe Bommarito of the Riverview Fire Protection District, who were not able to attend due to the weather.

Gina thanked everyone for the recognition and told the audience she remembered hesitating before running the first time. She was glad that she ran because she loved every minute of the last 18 years and wouldn't trade it for anything. Gina is planning to keep involved and run for the State Senate in 2012 when Senator Tim Green is term limited out.

Although Gina worked on many issues during her time in the House of Representatives, improving the quality of life for residents at the Bellefontaine Habilitation Center that houses some of the most developmentally challenged individuals in Missouri, was a priority. There is currently \$20,000,000 in improvements coming thanks to Gina and Tim's efforts. Construction should get underway this Spring.

Again, "Thank You," State Representative Gina Walsh, for not only representing the entire 69th District, but for being a part of our community and making a difference in all our lives.

### **Street & Bridge Repairs**

Phase 1 (2009) Street Repairs are complete.

Phase 2 (2010) street repairs are nearly 60% complete.

Phase 2 streets that are complete except for asphalt surfacing are: Kilgore (Coburg Lands to Ashbrook), Seaton, Addison, Avant, Cadora and Grenshaw.

The streets that only require the final asphalt surface will be completed within the first couple of weeks of construction commencing in March. The contractor needs temperatures over 50 degrees Fahrenheit or warmer to pour the asphalt surface.

Phase 2 streets that were not started in 2010 are: Biritz, Dwight, Golden, Hayward, Scenic and Surrey Lane.

Contractors are working on a list of proposed streets for Phase 3 (2011). Phase 1 was completed at a cost of \$1,711,269.19. Phase 2 is estimated to come in with very similar costs, leaving \$1.5 to \$1.7 million remaining for Phase 3. Streets in Phase 3 will be announced in the May edition of the BN News.

X-L Contracting notified the City of BN the Shepley Road Bridge was near completion and asked for a walkover on December 23, 2010, when the bridge was formally opened to traffic.

This project was scheduled to be complete over a year ago, but delays from the railroad forced postponements. Thanks for everyone's patience while the bridge was not in service. Please drive carefully.

### North County Post Office Takes Action To Improve Service

City of BN residents have had many complaints about poor mail service. After hearing complaints at the Board meeting on Thursday, November 18, 2010, Mayor Rudloff asked Alderman Shirley Paro to contact US Representative William Lacy Clay's office and get them involved.

Congressman Clay's Office, in turn contacted the Post Office and they have responded with the following improvements that will be made in the coming weeks:

- Regular carriers will be assigned to more routes this will decrease the potential of mistakes which are made because a relief/sub carrier is unfamiliar with the route.
- Vacancies will be filled which will decrease the need to pivot routes.
- A misdelivery log will be kept on all customer reported delivery issues.
- Errors will be immediately addressed with the carrier assigned to the route.
- Appropriate corrective action will be taken for recurring instances.

• Station Manager and Delivery Supervisors will be following up with customers who report recurring delivery issues to ensure that delivery service improves.

We are very pleased to see that both Congressman Clay's Office and the Post Office have acknowledged our problems and are working to improve mail service. We understand that this will take some time to implement the proposed changes, but we are looking forward to the improvement.

The Post Office has apologized for any inconvenience that there has been in the past and recommends that all complaints about postal service should be directed to the Manager, Evelyn Thomas or the Delivery Supervisors at 869-2319.

In the past weeks, The City of BN has been keeping track of complaints so we have an idea of the scope of the problems. We will continue to log all complaints that are called into City Hall and, if multiple complaints continue to come in, we will forward them to Congressman Clay's Office. Please be sure to note the date of delivery so the carrier can be identified and proper action can be taken. Your help in this matter will make a difference.

### **Gibson Artifacts Donated To Faust Park Historic Village**

When Frieden's United Church of Christ decided to close its doors, they took great efforts to do the job correctly, including finding a home for the artifacts from the Dr. James Gibson Home, named "Tanglewood," which was built around 1880 and still stands on the church property. Dr. Gibson and General Daniel Bissell were the two original land owners that had vast properties in what is now The City of BN.



The church was in possession of a cradle used by the Gibson Family, a cabinet, table, silverware, a place setting, crystal, figurines,

Items from the Gibson House, Tanglewood books, photo albums, pictures, paintings and other items including the Gibson Family Bible.

Church members searched for the best home for the artifacts, and decided to donate them to the St. Louis County Parks and Recreation Department. Under the direction of Jesse Francis, who is the curator for Faust

Park, the items were carefully packed and moved into the vehicles for transport.

After they are catalogued, most of the items will be on display at The Davis House in Faust Park Historic Village, 15185 Olive Boulevard, Chesterfield, MO. 63017 (Call 314-615-8328 for information on

tours, costs, etc.) The sixteen buildings in the village date from 1840 to 1900 and represent the lives of farmers, doctors, slaves, immigrants, trades people and inventors who lived in the small towns and farmland that are now St. Louis County. The addition of these artifacts will be greatly appreciated.

Since Dr. Gibson was one of the first landowners in what is now The City of BN, we have requested one of the portraits of Dr. Gibson be displayed at the Bissell House as a reminder of his contribution to the history of The City of BN.

Chief Pruett has served the citizens of Missouri for 46 years as a law enforcement officer. He served with the St. Louis City Police Department, the Florissant Police Department, and for the last nine years as the Chief of

Residential

Several weeks ago, a home in The City of BN, located on a busy, residential corner was burglarized during the afternoon hours. None of the neighbors saw anything or reported any suspicious activity. Our crime rates are comparatively low but break-ins are happening throughout the St. Louis area.

Burglaries are sporadic and often there are weeks without burglaries. When there is a trend in the neighborhood and burglaries are up, extra patrols are put on the street to try and keep our community safe with the resources we have. The BNPD needs your help.

Keep an eye on your neighborhood and call in suspicious persons, vehicles or activities. When burglars are caught, questioned by police or even notice neighbors watching them, they are more apt to move on.

A suspicious person is often someone who you do not recognize or have not seen before. Burglars don't



wear a mask or striped shirt like we see in cartoons; they look like regular people. The thing that makes them suspicious is they are somewhere they do not belong, doing something they shouldn't be doing.

#### **Burglaries**

When you see someone who does not belong in the area or at a specific home, call the police at 889-2341. If it is an authorized repairman, friend of the family or anyone with reason to be there, the police will speak to them and let them be on their way.

A suspicious vehicle is a vehicle that you do not recognize or have not seen before. The vehicle can be a bicycle, motorcycle, car or truck that does not belong in a neighbor's driveway or on the street. Jot down the license plate if you can read it, vehicle color and number of doors then call 889-2341. Again, the police will come by and check it out.

A suspicious activity is something that you can easily sense. A suspicious person walking out of a house with a backpack or a big screen TV, someone walking down the street knocking only at doors that do not have a vehicle in the driveway or a strange sound like breaking glass could mean there is a burglar in the neighborhood. Call 889-2341. Tell the police what you saw or heard and they will again respond and check the neighborhood out. You do not have to give your name; anonymous calls will be investigated.

By working together, we can make a difference and keep our neighborhoods safe.

### **Resources For Animal Problems**



Officer Sharie Pigot, St. Louis Animal Control was a speaker at the Neighborhood Watch Program in the fall of 2010. Sharie explained the difference in the ordinances of St. Louis County Animal Control and the City of BN. Both the City of BN and St. Louis County have good ordinances to protect animals and people, but they are very different. Each entity only enforces their own ordinances.

Working together, we can get the best of both resources. If you have a problem with a neighborhood animal, call 889-2341 and ask both the BNPD and Animal Control be dispatched. They will not duplicate fines or summons, but can make sure they will work together to get the best results for your problem. This fall, there was a new service started by St. Louis County called, "Heffie's Hotline." Heffie was a pit bull found in poor health on a very short chain in North St. Louis. Heffie became a poster child for this project because he represented what chained and mistreated dogs go through. The hot line is on 24 hours a day and allows you to remain anonymous. Follow the prompts and you can leave a request to investigate abuse or neglect, get information on spaying and neutering and much more. The number is 615-1777.

St. Louis County will address some wildlife issues, but they are limited in what they can do unless the animal is believed to have rabies. If you have a wildlife problem, call the Missouri Wildlife Rescue Center at 636-394-1880. The Wildlife Rescue Center is a non-profit Missouri organization that hospitalizes and rehabilitates native Missouri wildlife. Annually, they treat over 2,000 animals and field over 10,000 phone calls.

### What To Do If You Lose Power

- Check for a blown fuse or circuit breaker.
- Call AmerenUE at 1-800-552-7583.
- If you see power lines down, call 911 immediately.
- Listen to a battery powered radio for news and shelter information.
- Unplug appliances so when electric comes back on, it does not cause a drain or power surge.
- Dress warmly, in layers.

- Avoid opening refrigerator or freezer. If you have a generator, do not connect it to the home's power system unless it has been properly installed and disconnects you from the main power grid when operating.
- Use only approved alternate heating. Do not use kerosene heaters, BBQs or any other outdoor heaters that cause carbon monoxide.
- Check on elderly neighbors who may have medical equipment operated by electricity. Report these cases to the Riverview Fire District at 867-3889.

### War Of 1812 Symposium At The Bissell House

The 21st Annual War of 1812 In The West Symposium will be held on Saturday, March 26 from 9 AM to 5 PM and Sunday, March 27 from 9 AM until to Noon at the Daniel Bissell House, 10225 Bellefontaine Road.

The Symposium is held yearly and rotates between the Bissell House in the City of BN, Fort Osage, near Kansas City, MO and Arrow Rock, near Columbia, MO. The event is well attended by historians from all over the country.

### What To Know If You Are Planning A Garage Sale

With warmer weather on the way, many may be thinking of holding a garage sale to get rid of the things that clutter up their garages and basements. It's a good idea to recycle things instead of throwing them out.

Residents are required to have a permit for any sales.

Permits are issued free and available at the City Hall during working hours. Sales are limited to two a year and signs are not allowed on street corners, poles or trees. If you are planning a block or subdivision sale, please notify the BNPD to see if there is a need for signage, traffic control to keep streets passable.

### **Emergency Preparedness, 2011**

When the warning went out on February 2, 2011 that the region would be hit with a "Historic Winter Storm," people in The City of BN, along with the Riverview Fire Protection District sprug into action to prepare for the worst, even though it didn't happen.

The biggest worry had been addressed in 2009 when the Board of Aldermen approved the purchase and installation of an emergency generator that powers both the City Hall and Recreation Center during power outages. The unit is serviced periodically and tested monthly so it is always ready for emergencies.

During times like this Chief Pruett and Fire Chief Bommarito work very closely together to ensure the safety of our community. Chief Pruett and Chief Bommarito's check list looked something like this:

- Coordinate both agencies (Police and Fire) for the implementation of emergency plans in the case of a power outage.
- Contact the Red Cross for cots and blankets.
- Contact the St. Louis County Emergency Operations Center for emergency meals and bottled water;
- Get in touch with residents who may need emergency medical service.
- Coordinate with the Petroleum Company to insure an appropriate amount of fuel for the generator is available.
- Coordinate with Mark Dickerson about the use of the Recreation Center for a Warming Center.
- Contact the Public Safety Committee and CERT members to ask them to assist in manning the warming center, if needed.

Fortunately, this storm was not as bad as predicted and emergency measures were not required. **But we were prepared.** 

The next step is to contact St. Louis County Emergency Management and inform them we are prepared to host a warming or cooling center.



St. Louis County has to approve the center and takes over the media alerts.

City of BN residents are urged to keep this in mind and tune into the TV or radio or call the Recreation Center at 867-0700 to ask if the Center has been designated a heating or cooling center.

Residents who have life sustaining equipment that is dependant on utilities should contact the Riverview Fire Protection District and register. In case of an emergency situation, their needs can be addressed. The number to call is 867-3889.

Check on home bound or elderly neighbors. If the neighbor needs something you can't provide, call their family or 211. In many cases, homebound people are just glad to know someone is thinking about them.

Establish a daily contact with someone who could notify the PD in the event that you cannot be contacted. The officers in the PD are happy to check on the welfare of a resident.

Be prepared for emergency situations. Keep enough food, water and medications on hand so you are prepared for a week. Remember in a true emergency our immediate resources will be limited so each home should be prepared to be self sufficient for at least 72 hours.

During times of emergency situations, residents should call 911 for true emergencies ONLY. The United Way has a referral service that will deal with quality of life issues. Residents should call 211 for help during emergency and non-emergency events.

Thanks to everyone who offered their driveway to neighbors who park in the street due to limited driveway space. Getting vehicles off the street gives the

> street department the opportunity to get snow and ice off the streets so emergency vehicles can get through.

> Not only was the Public Works Department out clearing the streets, the Police Department was also on duty to answer calls. Thanks to everyone that works to help keep us safe during these emergency situations.
