
Election time is here. I have encouraged all of you in the past to exercise your right to vote. One vote can make a difference in an election; it could be yours. As Americans we share a freedom

BN Police Officers Recognized For Professionalism

On August 9, 2012, at approximately 1:50 A.M., a call was received of a flourishing of a weapon in progress in the 10800 block of Lilac. P.O. Laumeier and P.O.

McGary were dispatched to the call. P.O. Laumeier arrived on scene within a minute of the call being dispatched and contacted the victim of an apparent robbery. P.O. Laumeier gathered pertinent information and broadcast suspect information over the radio.

While P.O. McGary was responding to the scene, he observed a vehicle fitting the description of the suspect vehicle and conducted a traffic stop. P.O. Spieler responded to assist. Upon P.O. Spieler's arrival, four suspects were secured in handcuffs without incident. During a search of the vehicle, a loaded .38 caliber pistol was located underneath the rear passenger seat. P.O. Laumeier transported the victim to the scene where a positive ID was made.

After a thorough investigation and many hours of evidence seizure and paperwork, the case was presented to the St. County Prosecuting Attorney's Office. Arrest warrants were issued on two of the suspects with a bond of \$25,000 and two warrants were taken under advisement pending lab results.

For outstanding teamwork, coordination and their high degree of professionalism, P.O. Laumeier, P.O. McGary and P.O. Spieler were presented the Chief's Letter of Commendation.

During the period of February 2011 and February 2012, P.O. Kaltenbach has made thirty (30) "Driving While Intoxicated" arrests. During that same period of time the police department as a whole made a

total of seventy one (71) "Driving While Intoxicated" arrests. P.O. Kaltenbach made over 40% of all the D.W.I. arrest for the police department.

For his high degree of professionalism and outstanding performance of duty P.O. Kaltenbach was presented the Chief's Certificate of Merit.

During the period of February 2011 and February 2012, P.O. Shaw has made thirty (39) "Drug Violation" arrests. During that same period of time the police department as a whole made a total of ninety-five (95) "Drug Violation" arrests. P.O. Shaw made over 40% of all the Drug Violation arrest for the police department.

Watch For Our New Sign At Bellefontaine & Chambers

The Mayor and Board of Aldermen are committed to better communication with residents and improving our "North County" image. We all know the City of BN is a wonderful place to live, but not everyone knows, so we are taking some actions to try to tell them.

The sign in front of City Hall has seen better days and would soon need to be replaced. Instead of replacing that sign the Board of Aldermen has approved a contract for a 2 sided electronic LED sign at the corner of Bellefontaine and Chambers Roads in Klein Park. The lowest bid came from SOI Sign Company, a St. Louis County company, at \$22,231.00.

The sign is 4' by 8', will have approximately 30" by 80" message area and can be programmed by a computer in the City Hall complex. The sign will be used to advertise events and make sure residents are aware of important issues. The sign is expected to be in place around Thanksgiving, weather permitting.

In order to improve our image outside our city, we have taken out an ad in the Community News and we will be submitting articles and event notifications. The Community News is a free, weekly publication available at most grocery stores, including Bill's Market and Meats, Schnucks and Shop 'n Save.

How The City Of Bellefontaine Neighbors Got Its Name

What we now know as the "Louisiana Territory" included 828,000 square miles and most of 15 states West of the Mississippi, including the area that is now the City of Bellefontaine Neighbors.

The history of our city starts around 1699 when French Explorers claimed the territory for France.

"Perhaps some two (and a half) centuries ago, a Frenchman, groping his way through the untrekked wilderness of a new world came to the confluence of the two mightiest rivers on earth. Then he paused and turned westward, and pursued the south bank of the river that flowed from the northwest. As the Frenchman fought his way through the ranks of

gnarled vines and saplings, he came a short distance from the receiving stream, to a freshet of water issuing from a cave in the side of the bluffs that lined the river. Hesitating to drink, he was struck not only by the beauty of the spring itself, but also by the loveliness of its environs, and ascending the steep slope, stood on its peak to survey the scene. He saw the Missouri, making a wide sweep, carefully avoiding an islet which lay in its path like a huge turtle sunning its green back. The river swings against the bluff which rises to a great height above it. Across the flats in a distance are the cliffs that line the eastern bank of the Mississippi, and barely visible is the Father of Waters itself, welcoming the issue of its sister from the west. The green of the hills and flats blend with the blue of the sky and the colors of wild flowers and all over lies the gray, lazy haze which marks great inland bodies of water. Descending after he had viewed the magnificent panorama, he went back to the spring, and again fascinated by its quiet beauty and entranced by what he had seen, turned to his companions and said. "C'est une belle fontaine." The Frenchman went on his way, but he left the name, and so it is today- Bellefontaine - beautiful fountaine."

The French ceded the Louisiana Territory to Spain in 1762 and reclaimed the land in 1800. France had to abandon plans of controlling the territory because of internal problems and sold the entire Louisiana Territory to the United States in 1803 for \$15 million or \$.03 an acre.

The United States built the first US Fort and Indian trading post west of the Mississippi and named it Fort Belle Fontaine. Lewis & Clark and Zebulon Pike were some of the explorers that began their journeys of exploration from Fort Bellefontaine. The road linking City of St. Louis to the Fort was and still is Bellefontaine Road.

In the late 1600's when the Frenchman discovered the spring, it was a large spring. In the early 1800's, when the fort existed, the spring supplied enough cool, clean water for more than 2,000 soldiers daily. Since that time, the spring is reduced to a trickle, and is rarely seen unless water levels are low.

St. Louis County Government was organized in 1812 and what is now Bellefontaine Neighbors was "unincorporated" St. Louis County. After World War 2, the area anticipated the building boom that would take the population from 766 in 1950 to 13,650 in 1960. A group of residents got together to talk about incorporating what is now the City of Bellefontaine Neighbors so the building boom could be controlled locally. Bellefontaine Road was the main Road and so it was decided Bellefontaine would be the name of the city. Al Roth, lifetime resident, remembers someone said, "Well, we are all neighbors, so lets call it Bellefontaine Neighbors." And it was decided. The city was incorporated on June 19, 1950.

City Of BN Thanks Senator Green For His Service

Residents of the City of BN had an opportunity to thank Tim Green for his 24 years of Public Service on September 20, 2012, at the City's Annual Town Hall Meeting.

Tim was elected to the Missouri House of Representatives in 1988 and to the Missouri Senate in 2004. Missouri term limits restrict Tim from running for another term.

Significant legislative accomplishments during Tim's political career include a bill that brought Conservation Areas to St. Louis County and the Missouri Veterans home to The City of BN. He sponsored a truth in sentencing bill that would require prisoners to serve 85 percent of their sentence; a bill to redistribute sales tax dollars

to St. Louis county municipalities; and worked tirelessly with Representative Gina Walsh so the developmentally disabled would always have a home at the Bellefontaine Habilitation Center.

In honor of Tim's 24 years of service, Mayor Robert J. Doerr presented a plaque dedicating the pavilion at the Miniature Golf Course as "The Timothy Green Pavilion," in recognition of his service. Tim thanked Mayor Doerr and the residents for their support over the years.

We all wish Tim, his wife Lisa and their children well in the future and are glad we had the opportunity to work with Tim during his political career.

The facility is rated as one of the best Veteran's facilities in the Nation and Bob will tell you its the best!

The first things you notice upon walking into the facility is that it's clean and spacious. Staff is buzzing around and everyone of them addresses each resident by name. All around the facility there are gathering places where residents can visit with each other or family, watch TV, lounge

around in recliners or participate in exercise.

There is a never-ending list of volunteers who come to help and entertain the residents with music, bingo, shows and sometimes just to sit and talk to residents. The activities department's calendar full with everything from Bingo, discussions about current events, bus trips to malls, restaurants, the race track and casinos. One of Bob's favorite activities is Happy Hour; especially when it is held on the outside patio.

The MVH has amenities such as a physical therapy pool, chapel, beauty/barber shop and wheel chair accessible walking paths on the grounds.

Even though Bob has been known as a "picky-eater," he says the food is good. Even when the entree of the day is listed as liver and onions, he's not worried because there are always other choices.


Bob loves it at the MVH and, with the help of family and friends, can still be a part of the BN Community he loves and still see his own doctors. Bob recommends the MVH to any Veteran and urges them to apply early because there is a waiting list.

To be eligible to reside at the MVH, you must be a citizen of the State of Missouri, served on active duty and discharged under honorable conditions. The facility has several levels of service and the cost of care is based on income and disability. "Honor Flight" To World War II Monument in D.C.

Greater St. Louis Honor Flight (GSLHF) is a not-for-profit organization that sends World War II Veterans to Washington DC to see the WW II Memorial. GSLHF was created by St. Louis women who were passionate about ensuring local veterans had a chance to see the memorial dedicated to them. Since its inception in 2009, the GSLHF has sponsored twenty-two Honor Flights for 674 veterans.

The tour starts about 3 AM when Veterans and their chaperones leave for Lambert Field and catch a flight to the D.C. area. They head straight to the World War II Memorial by chartered busses. Once there, our veterans have time to visit the amazing memorial, surrounded by the majestic Capitol Mall.

They also visit the Korean War Veterans Memorial and the Vietnam Veterans Memorials. Before departing D.C. they view "The Changing of the Guard" at Arlington National Cemetery and return to Lambert field around midnight.

City of BN resident Clarence Cherry made the trip in August and Robert P. Doerr is scheduled to make the trip on October 23. Although the trip is exhausting, it is also rewarding because it shows their efforts, during World War II, are acknowledged and appreciated. Clarence says it was a trip to remember and was glad to have the chance to go.

In 2008, The City of BN established "Snow routes." These snow routes, designated by signs, prohibit parking when there is a prediction of two (2) inches of snow or ice. This was done so snow plows can get through to clean the streets so emergency vehicles have ready access at all times for the health, safety and well being of our residents. (Per ordinance 2096.)

You can help even if you do not live on a snow route by keeping as many vehicles off the streets as possible. The Street Department can do a better job of cleaning our streets. If you don't have a vehicle, offer your driveway to a neighbor. Your house will look more lived in and it makes your snow removal easier, too.

Report Street Lights That Are Not Working Properly

Street lights make our city a safer place, but when they are not working, they don't do their job. If you have a street light that is not working properly, take a minute to turn it in so Ameren can get out to fix it.

To report a street light that is not working, call City Hall at 867-0076 or Ameren at 342-100. You can

report the light by address but it is more helpful if you can get the light number. The light number is on a band up on the light fixture, and usually has some letters and numbers, such as BN-52. This number tells Ameren exactly where the light is and they usually respond faster than they do if you just give an address.

Charges For False Alarms

In 2012, (January thru September) BN Police Officers have responded to 587 false alarm sounding reports. When police officers respond to "Alarm Sounding" calls it creates a dangerous condition not only to the public but to the officers. In September

of 1992, the Board of Aldermen passed Ordinance 1522 which establishes regulations for alarm systems and provides for penalties for "False Alarms" caused either by misuse, by resident error or equipment failure. If the "False Alarm" is caused by resident error or equipment failure please call 889-2341 and cancel the alarm immediately. If the alarm is not canceled the officers responding will leave a written report for the resident. If the "False Alarm" is caused by inclement weather or equipment malfunction which required repair or replacement by the alarm company call the

police department and request a waiver of fees. Any "False Alarm" that the police department responds to that has not been canceled shall result in the following charges:

- 1st false alarm in a calendar year: A warning will be issued.
- 2nd false alarm in any calendar year at a premises: a fifteen-dollar (\$15) charge.
- 3rd false alarm in a calendar year at a premises: a twenty-dollar (\$20) charge.
- 4th and any subsequent false alarms in a calendar year at a premises: twenty Five-dollar (\$25) charge.

NOTE: Charges must be paid within 10 days of receipt of written notice. For more info call the police department at 867-0080 during business hours.
