## CITY OF BELLEFONTAINE NEIGHBORS BOARD OF ALDERMEN MEETING MINUTES November 6, 2014

**MEETING WAS CALLED TO ORDER BY** Mayor Robert J. Doerr at 7:30 p.m. Copies of all ordinances and resolutions to be considered at the meeting were made available for public inspection prior to the time of consideration by the Board of Aldermen.

PLEDGE OF ALLEGIANCE TO THE FLAG was led by Mayor Doerr.

#### **ROLL CALL:**

### ABSENT:

**APPROVAL OF THE AGENDA:** Alderman Jordan moved for the approval of the Agenda, seconded by Alderman Roth. Motion carried unanimously

**PRESENTATION OF THE UNAPPROVED MINUTES:** Alderman Jordan moved for approval of the October 16, 2014, Minutes of the Board of Alderman Meeting, seconded by Alderman Schultz. Motion carried unanimously.

**MEETING OPEN TO THE PUBLIC:** Alderman Jordan moved to open the meeting to the public, with a 3-minute limit, for as long as the Mayor deems necessary, seconded by Alderman Merz. Motion carried unanimously.

Mayor Doerr asked if anyone wished to address the Board. Hearing none, Alderman Jordan moved to bring the meeting back to the Board, seconded by Alderman Dillworth. Motion carried unanimously.

## **COMMISSION AND BOARD REPORTS:**

**PUBLIC SAFETY COMMISSION:** The Board reviewed the October 23, 2014, Minutes. Alderman Dillworth reported on the issues brought up at the meeting:

- The addition of more street lights on certain streets Deni has already emailed Stephanie, at Ameren, to ask about the cost to buy a light pole and how to go about getting brighter lighting. Mayor Doerr thought the city would have to pay about \$2000 per pole for the installation and then the pole is dedicated to the city to resume the monthly payments;
- Would like to put speed bumps on Duenke due to the speeders, but was told it would not be a good idea due to emergency vehicles not being able to get through;
- Chief Pruett reported another speed limit sign was installed on Duenke along with moving the current sign to another location due to an obstruction. Also, a "Children at Play" sign has been erected; and
- Parking on both sides of Green Acres is a problem. It was suggested to put up No Parking signs on one side of the road. These streets are private so it is up to the residents as to what they want to do.

YOUTH COMMISSION: The Board reviewed the October 20, 2014, Minutes. Alderman Schultz reported there will be a Valentines Craft Night in February. Family Halloween Fun Night went really well; thanks to Amy Mulholland for her help. They collected a lot of canned

goods to help other pantries. Thanks to Mayor Doerr for attending this event. They are in the process of planning the next D.A.R.E. Dance

**IMAGE & BEAUTIFICATION COMMISSION:** The Board reviewed the October 14, 2014, Minutes. Alderman Smith reported homes will be judged for their Christmas decorations on December 16<sup>th</sup>. Mayor Doerr would like to see some new homes win this year. A discussion continued about what awards may be given out to the winners. Mark Dickerson will look into matching grants regarding bushes, trees, etc...

PARKS BOARD COMMISSION: The Board reviewed the October 21, 2014, Minutes.

**PARKS & RECREATION DIRECTOR:** Mark Dickerson reported on the following roof bids the city received; there is money available in his budget:

Frederic Company, Inc. \$47,000.00 (selected)

Lakeside Roofing Company \$70,579.00

Ferguson Roofing Chose not to submit

Per Mark's recommendation, Alderman Roth made a motion to approve the selection of Frederic Company, seconded by Alderman Merz. Motion carried unanimously.

BILL NO. 2386 - INTRODUCED BY ALDERMAN ROTH

AN ORDINANCE AUTHORIZING AN AGREEMENT WITH FREDERIC COMPANY, INC. FOR ROOF REPLACEMENT AT THE RECREATION CENTER.

Alderman Roth read the Bill for the first time and moved for approval of the first reading of Bill No. 2386 and to go on to the second reading. The motion was seconded by Alderman Migliazzo. Motion carried unanimously. ## BILL NO. 2387 - INTRODUCED BY ALDERMAN DILLWORTH

# AN ORDINANCE AMENDING CHAPTER 19 OF THE BELLEFONTAINE NEIGHBORS CITY CODE RELATING TO OFFENSES AGAINST PUBLIC PEACE AND SAFETY.

Alderman Dillworth read the Bill for the first time and moved for approval of the first reading of Bill No. 2387 and to go on to the second reading. The motion was seconded by Alderman Smith. Motion carried unanimously. Alderman Dillworth then read Bill No. 2387 for a second time and thereafter made a motion that the Bill be approved by the Board of Alderman for enactment as an Ordinance, seconded by Alderman Smith. AN ORDINANCE AMENDING SECTION 2-42 OF THE BELLEFONTAINE NEIGHBORS, MISSOURI, CODE OF ORDINANCES AND ADOPTING AN AMENDMENT TO THE PERSONNEL RULES AND REGULATIONS AND PERSONNEL HANDBOOK FOR THE CITY OF BELLEFONTAINE NEIGHBORS PERTAINING TO FAMILY AND MEDICAL LEAVE.

Motion carried unanimously. Alderman Paro then read Bill No. 2389 for a second time and thereafter made a motion that the Bill be approved by the Board of Alderman for enactment as an Ordinance, seconded by Alderman Merz. Alderman Jordan read the Bill for the first time and moved for approval of the first reading of Bill No. 2390 and to go on to the second reading. The motion was seconded by Alderman Roth. Motion carried unanimously. Alderman Jordan then read Bill No. 2390 for a second time and thereafter made a motion that the Bill be approved by the Board of Alderman for enactment as an Ordinance, seconded by Alderman Roth. - X-Tra Help will host a Job Fair at the Rec Center on November 14<sup>th</sup>;
- City Hall will be closed on Veteran's Day;
- The Boy Scouts will be camping out at Wilderness Park this week-end;
- Maclan Industries is expanding their business, located at 9601 Lilac;
- The American Red Cross has asked the city permission to use the Rec Center as a shelter, if need be, when the decision is announced;
- The Auditors will be at the November 20<sup>th</sup> Board Meeting to present their findings on the yearly audit; and
- Mayor Doerr had lunch with Judge Haywood last week, who is recuperating. Hopefully he will be back at city hall after the 1<sup>st</sup> of the year.

#### REPORT OF THE ALDERMEN:

**ALDERMAN DILLWORTH:** Reported the Public Safety Commission will not meet until January 22<sup>nd</sup>. Thanked Mayor Doerr, Chief Pruett and Deni for their help with the issues brought up by Public Safety. Since Green Acres Road is private, the Trustees will have to decide whether to put up No Parking signs on their road.

### ALDERMAN MIGLIAZZO: No report given.

**ALDERMAN PARO:** The Newsletters will be given out this week-end by the Boy Scouts. Since New Year's Day, January 1<sup>st</sup> falls on a Board Meeting night, Alderman Paro made a motion to cancel the meeting, seconded by Alderman Jordan. Motion carried unanimously. There was a small discussion whether to cancel the December 18<sup>th</sup> meeting; it was not. She announced, on November 1<sup>st</sup>, she and Norvel celebrated their 45<sup>th</sup> Wedding Anniversary.

**ALDERMAN SCHULTZ:** Congrats to the Paros on their anniversary and thanks to Alease for joining the Youth Commission.

ALDERMAN MERZ: Wished everyone a nice Veteran's Day. Congrats to Shirley and Norvel.

ALDERMAN JORDAN: No report given.

ALDERMAN ROTH: Asked everyone to be safe and be good neighbors.

**ALDERMAN SMITH:** Welcomed all to attend the Veteran's Day celebration at the Veteran's Home next Tuesday at 10 a.m. He recently helped with BINGO, at the Vet's Home, and had a good time. Reported there was a low turnout at the last Neighborhood Watch. He asked Chief Pruett if the Officers would start slowing down a little bit, when patrolling, and stop and talk more to the residents. He asked everyone to be alert and be prepared just in case there are problems after the decision. Congrats to Paros and Deni (tonight is her 8<sup>th</sup> year with the city).

**MARK TRANEL:** The Special Administrative Board is meeting next Tuesday night; all are welcomed. He reported three schools in the Riverview Gardens School District received an Apple ConnectEd computer grant which will provide an iPad for every student, a Mac and iPad for every teacher and administrator, an Apple TV for every classroom, and other items. The three schools are Central Middle School, Riverview Gardens High School, and Westview Middle School.

Mayor Doerr asked Collector Tranel to get back to him about whether the SRO funds are in the school budget.
