Dear Mayor Tommie Pierson, Sr,

My name is Wynn Greene calling on behalf of Longview Technology Solutions or (LTS) and the LTS Teaming partnership HUB/ SDVOSB Veterans Lab Services (VLS.) The purpose for writing to you today is to share with you how we can help your organization schedule and set up end-to-end community-based COVID-19 testing events for First Quarter 2021.

And, as a previous Regional Director of an end-to-end community-based COVID-19 testing operations in North Texas, I led multiple CDC compliant COVID-19 testing teams that spanned from West Texas near New Mexico to East Texas and the Louisiana border. These TDEM (Texas Department of Emergency Management) sponsored locations were both drive through and walk-up sites giving local residents access to the highest standards of COVID-19 screening and testing.

I want to make you aware that the State of Missouri has already established contracts with vendors to conduct end-to-end communitybased COVID-19 testing events for the duration of the contract period --- say First & Second Quarter 2021; and your municipality does not in fact have to go through the process of creating, publishing and soliciting an RFP.

Second, ALL "Community-Based Testing" in the context of COVID-19 testing is provided free of charge to any Missouri resident enrolled at the testing event; no insurance information is required nor is any fee collected from the individual at the testing event.

Third, as a point of clarification, the concept of "End-to-end" testing shall include but not be limited to the entire testing process from registering individuals for testing; securing logistics for the collection event; the collection of specimens; testing of specimens; reporting back to the requesting entity (RE) - (i.e. your organization); reporting to the Missouri Department of Health and Senior Services (DHSS); and notifying individuals of their results.

And finally, I want you to know that the Contracting Vendor will provide for you: all supplies, Personal Protection Equipment (PPE) and specimen collection kits; the appropriate "qualified Staff" need to conduct the 'testing event"I; waste disposal according to the State of Missouri regulations; appropriate language translation services; they will ensure that the proper Safety and Security measures are in place (i.e. signage; traffic cones; privacy; and social distancing measures; and under normal circumstances collection time / testing time should not exceed an average of 30 minutes.

Ultimately, after knowing this would you be open to discussing the possibility of having your organization schedule and set up an endto-end community-based COVID-19 testing event for First and Second Quarter 2021?

Please reply back that you received this email at your earliest convenience. I look forward to receiving your response and setting up a 10 -15-minute phone call with Parker Cowand, Director, National COVID-19 Screening, Testing & Vaccine Dispensing,

The Youth Volunteer Corps (YVC) of St Louis would like to have a Litter Pick Up Event in Bellefontaine Neighbors on Saturday, March 6th, from 10am until 2pm. Their primary mission is "to create and increase volunteer opportunities to enrich youth, address community needs, and develop a lifetime commitment to service".

I was contacted by Alderman James Thomas who was contacted by Marquetta Mansion of YVC. After speaking with Alderman Thomas, I contacted Marquetta for more information.

She stated that there would be approximately six to eight youth between the ages of 11-18 along with three adult escorts. They would pick up litter along two or more roadways.
