

The Minutes for the Park Board Meeting held on Tuesday, September 18, 2018 at Bellefontaine Neighbors Recreation Center.

Mark Dickerson opened the Park Board Meeting at 7:00 p.m.

Present: Kathy Endorf, Judy Mantych, Tina Swindle, Dave Cross and Mark Dickerson; Director of Parks & Recreation

Absent: Jane Davis and Alderman Don Merz

A discussion followed concerning receiving 5 bids for the Bissell Hills Park renovation on September 7, 2018. The winner of the bid is R.V. Wagner. Mark stated we'll present it to the Board of Alderman at the meeting on Thursday before the Town Hall Meeting. A discussion followed concerning contrast colors and trees.

Mark reported Amy's BBQ Dinner on August 28th went well. There were 42 people in attendance and the food was good.

The Beer & Wine Social will be held on Saturday, October 6<sup>th</sup> starting at 5:30 p.m. and runs until 9:30 p.m.

A discussion was held concerning the Recreation Center fees. We have the fees for most of the North St. Louis County Communities. We'll go over them today and you can take them with you. A discussion followed. We let residents with Recreation Center I.D. Cards walk in the gym, play basketball and use the Game Room with no daily user fees. There are daily user fees for the use of the Weight Room, Swimming Pool and Racquetball Court. A discussion followed. Mark reported some other Cities are offering a non-resident pass. A discussion followed concerning allowing extra guests as long as the resident asks us and if there isn't a lot going on we can consider it. A discussion followed concerning family passes. Martha Snead mentioned big groups won't know the rules or have proper swimwear. Mark mentioned with non-resident passes you have the advantage of knowing who they are. A discussion followed concerning making rules on how many guests a residents can bring in. Mark suggested the Park Board Members look the information over and we can possibly put something together either next month or the following month. We need to raise the fees a little for classes as well as the Weight Room. A discussion followed. Martha reported there are more non-residents than residents participating in our programs. A discussion followed concerning the cost of part time employees. Mark reported they use to make \$3.00 per hour and now they're up to \$7.00 to \$10.00 per hour. Mark asked the Park Board members to go through the suggested plans and familiarize your selves with it and note any possible changes on fees. A discussion followed concerning raising the amount of the deposit for the Meeting Room Rentals due to the condition and damage attained on some of the reservations as well as having a check out at the Park Reservations as well. Mark reported we're picking a contractor on Thursday and I hope by our next meeting they are starting to work on Bissell Hills Park.

A discussion followed concerning Kathy Endorfs' email not working as well as putting up a sign for Pickleball.
