#### **COURT ORDER**

# VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES EFFECTIVE MAY 1, 2019

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judges of the City of Bellefontaine Neighbors hereby orders that the following designated offenses shall be payable to the City of Bellefontaine Neighbors Violations Bureau. In such cases, no court appearance is necessary.

It is further ordered that the Court Clerk(s) are designated as violations clerks for said Violations Bureau, and shall perform the duties required by the Court including accepting appearance, waiver of trail, plea of guilty, and payment of fines and costs in traffic offenses as set forth below. It is further ordered as required by Rule 37.49, that this schedule be prominently posted as the place where fines are to be paid. Payment of scheduled fine and costs shall constitute a plea of guilty or waiver of trial.

#### Court Costs:

In accordance with Missouri statutes and ordinances adopted by the City, total Court Costs shall be \$24.50. This includes Basic Court Fees of \$12.00, Crime Victim's Compensation Surcharge of \$7.50, Law Enforcement Training Fund of \$1.00, Peace Officer's Standard Training Fund of \$2.00 and Domestic Violence Shelter Fund Surcharge of \$2.00; for a total of \$24.50. Court costs shall be paid in addition to the fine.
