ORDINANCE NO.

AN ORDINANCE APPROVING A CONDITIONAL USE PERMIT TO NORTH COUNTY FIRE & RESCUE FIRE PROTECTION DISTRICT FOR CONSTRUCTION AND OPERATION OF A FIRE HOUSE AT 805 CHAMBERS ROAD.

WHEREAS, the Zoning Code Of Bellefontaine Neighbors provides that the Board of Alderpersons may, by a conditional use permit issued under the provisions of Section 29-94 et seq., authorize the use of property in the R-3 Single-Family Dwelling District for "any use permitted in the R-1 Single-Family Dwelling District", which permits "any use designated as being a conditional use" in the R-1 Single-Family Dwelling District under the terms of Article XVI Conditional Use Regulations of the Zoning Code of the City; and

WHEREAS, the North County Fire & Rescue Fire Protection District (the "Applicant") has acquired that re-subdivision plat, being entitled STEINMANN AND COBURG LANDS SUBDIVISION BEING PART OF LOT 1 OF COBURG LANDS AND LOTS 6 THROUGH LOT 12 INCLUSIVE OF STEINMANN SUBDIVISION U.S. SURVEY 1829, TOWNSHIP 46 NORTH, RANGE 7 EAST, CITY OF BELLEFONTAINE NEIGHBORS, ST. LOUIS COUNTY MISSOURI, located at 805 Chambers Road, and subject to the zoning and subdivision ordinances of the City of Bellefontaine Neighbors and all other legal restrictions, conditions, easements and ordinances affecting same; and

WHEREAS, the Applicant has requested that it be allowed to construct a new fire house on the property at 805 Chambers Road; and

WHEREAS, the application was referred to the City Planning & Zoning Commission, which studied the application and the recommendation of City staff and, at its December 13, 2021 meeting, recommended approval of the application by the Board of Alderpersons as submitted by the Applicant; and

WHEREAS, the Board of Alderpersons gave due notice and held a public hearing on the application via video teleconference, on Thursday, March 3, 2022 at 7:30 P.M., when the Board heard and considered comments and suggestions by those present; and

WHEREAS, the Board of Alderpersons has determined, in accordance with the provisions of Section 29-95(2) of the Zoning Code that the granting of a conditional use permit will:

a. Comply with all provisions of the applicable district regulations.

- b. The proposed conditional use at the specified location will contribute to and promote the welfare or convenience of the public.
- c. The proposed conditional use will not have a deleterious impact on the value of other property in the neighborhood in which it is to be located.
- d. The location and size of the conditional use, the nature and intensity of the operation involved in or conducted in connection with it, and the location of the site with respect to streets giving access to it are such that the conditional use will not dominate the immediate neighborhood so as to prevent development and use of neighboring property in accordance with the applicable zoning district regulations. In determining whether the conditional use will so dominate the immediate neighborhood, consideration shall be given to:
 - 1. The location, nature and height of the proposed buildings, structures, walls, lighting and fences on the site; and
 - 2. The nature and extent of proposed landscaping and screening on the site.
- e. Off-street parking and loading areas are provided in accordance with the standards set forth in these regulations.
- f. Adequate utility, drainage, and other such necessary facilities are provided.
- g. The proposed conditional use is consistent with good planning practice; can be operated in a manner that is not detrimental to permitted developments and uses in the district; can be developed and operated in a manner that is visually compatible with permitted uses in the surrounding area; and is deemed essential or desirable to preserve and promote the public health, safety, and general welfare of the City of Bellefontaine Neighbors.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERPERSONS OF THE CITY OF BELLEFONTAINE NEIGHBORS, MISSOURI, AS FOLLOWS:

Section 1. The Board of Alderpersons hereby approves a Conditional Use Permit ("CUP") to Applicant to operate First Responder Facility/Community Building fat 805 Chambers Road, subject to the following conditions:

- 1. All provisions of the City Code shall apply except where modified in this CUP Ordinance.
- 2. Once the conditional use permit has been recorded with St. Louis County, the applicant will provide proof of registration.

- 3. This conditional use permit shall be personal to the Applicant, shall not run with the land and shall not be transferred without the appropriate approval from the Board of Alderpersons.
- Section 2. This ordinance shall not be printed in the Code of Bellefontaine Neighbors.

Section 3. This ordinance shall take effect and be in force from and after its passage and approval as provided by law.
