The Minutes for the Park Board Meeting held on Tuesday, July 17, 2012 at Bellefontaine Neighbors Recreation Center.

Mark Dickerson opened the Park Board Meeting at 7:34 p.m.

The Minutes for the Park Board Meeting held on Tuesday, June 19, 2012 were accepted as presented. Mark Dickerson introduced Dave Cross to the Park Board members.

A discussion was held concerning the upcoming Adult Pool Night. Alderman Merz was concerned with the number of lifeguards on duty as well as the beer supply since we are expecting a large crowd. It was also mentioned there could be several birthday celebrations held during the Adult Pool Night. Jane Davis said she was giving up her Cardinal's tickets in order to celebrate birthdays. Don Merz mentioned if we run low on beer he will go pick up more if needed.

Mark Dickerson mentioned we have set a date for the American Sign Language Class. The class will run on Thursdays from 6:30 to 7:30 p.m. and the session dates are August 2 through September 20. We will also put it in the Fall/Winter Brochure and see how it goes. Jane Davis asked if there is a minimum number of participants for the class to run and Mark stated initially I said 5 but Susan mentioned she'd be willing to do it for even 1 or 2. Mark said I really wouldn't want to run it with 1 person so we'll wait and see what happens. If we could get around 5 I'd like to have it. She does have a maximum of 15. If we end up getting 3 people we'll have it and see how it goes.

Mark mentioned attending the meeting for the grant for the new bus and they will be awarding the grant on July 25th. Hopefully, by the end of this month we'll know if we are getting a new bus, since we've been having air conditioning issues this summer. A discussion followed concerning what we'll do with the old bus. Mark said he'd rather get rid of our oldest bus because the air conditioning and lift work on the newer bus but we don't own the newer bus because we obtained it through a grant.

Mark mentioned he is getting an electric sign at Klein Park. A discussion followed concerning how tall the sign will be as well as how it will be programmed. Mark said it can be programmed for 3 to 4 weeks at a time. The subject of the sign in front of the Recreation Center came up and Jean Garascia suggested moving the phone number to the bottom of the sign and put the information up higher so you can see it. She said the rose bushes are so high you can't see the sign. Mark said he will need to trim the rose bushes in the fall or spring. He also mentioned the whole sign needs to be rebuilt and he would like to do it before it falls down.

Mark mentioned the Recycle Program and said we are trying to get as many households involved as possible. Judy Mantych mentioned you should clean everything you recycle.

Mark reported the date for the Fall Golf Tournament is October 6th and the Beer/Wine Event will be held on October 13th. Alderman Merz suggested holding both events on the same date. He suggested starting the golf tournament earlier and Mark stated the golf course usually works us in around their normal schedule. Mark said he'd be open to other options but I usually plan on 2 weekends. Alderman Merz suggested contacting Jack Daniels in Tennessee as well as other manufacturers for donations for our events.

Alease Dailes mentioned having a problem with her neighbors parking in front of her house. She also mentioned a neighbor's puppy chewing on the fence and other metal objects and said she's afraid her grandchild may be attacked.

Mark mentioned an incident that occurred at the outdoor pool. A child ran into the slide on the pool deck. He hit his forehead on the slide and fell back on the deck hitting the back of his head. Mark said everyone on staff did exactly what they should have.
