

### **Facility Admission Policy and Rules**

1. All patrons must abide by the department's ID, Pass, Fee, and Guest Policies.

2. Inappropriate language or conduct perceived as threatening, inappropriate or less than family-friendly will not be tolerated and will result in removal from the facility.

3. Children 9 years of age and under must be with an adult age 16 or older at all times. An adult must remain in the building with the children during family time.

4. Guests must stay with the resident at all times. The resident is responsible for the guest's behavior. Misconduct of either party will result in the removal of both.

5. Proper attire is required in every area of the recreation facility at all times. This includes the wearing of shirts in the gymnasium, hallways and weight room as well as pants that cover any and all under clothing.

6. Weight room users must complete a release form. All users must bring a sweat towel and abide by the rules attached to the form.

7. Each resident is allowed one guests in the pool during open or lap swim. Non-resident swim guests must pay appropriate fee for admission.

8. All patrons on the pool deck whether you are swimming or not must pay the admission fee.

9. Properly lined swim attire is required. No gym shorts, leotards, sport bras or street clothes are allowed in the pool.

10. All diapers must be changed using the diaper changing stations located in the locker rooms.

• Memberships include access to gymnasium, weight room, indoor pool, outdoor pool.

- Every membership must purchase a Resident/Non-Resident ID card for individuals 4 years of age and older.
- Renew Active/Silver Sneaker members must be enrolled in the program through their health insurance.
- Non-Resident ID Card is only valid with a purchase of a membership. Not for daily admission fees.
- Outdoor pool membership only allows access to the outdoor pool from Memorial Day to Labor Day.
- Residents and Members are allowed to have one paying guest per day.

Recreation Department resident ID cards are required by all residents four years of age or older to enter the facility, use the gymnasium, pool, sauna, racquetball court, to reserve rooms or parks or receive resident rates for classes. With a resident general ID card, you pay daily user fees each time you swim, workout or play basketball, unless you have purchased a membership Pass. All passes also require a general ID card.

 $\cdot$  All ID cards and passes will be valid 1 year from date of purchase

## To get a resident ID card you must:

- 1. Be on a current Bellefontaine Neighbors occupancy permit.
- 2. Bring a picture ID showing your Bellefontaine Neighbors address (driver's license, school or work ID).

3. Bring your occupancy permit, utility bill, or bank statement if your picture ID does not have your Bellefontaine Neighbors address.

4. Bring a parent with a picture ID if a child does not have the required identification.



# **Fitness Center**



- Persons using equipment in the Fitness Center are responsible for their own safety. Patrons are advised to seek assistance from our staff if necessary.
- Respect for the equipment, facilities, and staff must be demonstrated at all times.
- Admittance to the Fitness Center is designated for ages 15 and up.
- Climbing or playing on the equipment is prohibited. We ask that all guests pay special attention to this rule and their children when renting rooms in the facility.
- Personal Training is limited to staff hired by the City of Bellefontaine Neighbors. Patrons or Personal Trainers who are not staff are not permitted to train clients or members for free or compensation. Doing so may lead to the revocation of access at the Recreation Center.
- Clothing must be dry, cover hips, and midsection, and be free of exposed rivets or chains.
- Shirts must be worn at all times.
- Close-toed shoes must be worn at all times. Exercising without shoes is prohibited.
- Eating is not allowed in the Fitness Center. We ask that patrons consume food in the lobby outside the Fitness Center.
- Beverages must be in control-top containers at all times.
- Only personal devices with headphones are allowed in the Fitness Center. Broadcasting personal music without headphones is prohibited.
- Patrons are asked to refrain from taking or making phone calls in the Fitness Center. Calls should be taken in the lobby.
- Floors and walkways must be free of personal belongings and bags. Place items in lockers in lobby or locker rooms.



The hiring process for the Chief of Police is as follows:

- 2. Application
- 3. Written questionnaire assessment completed by each candidate.
- 4. Interviews:
  - Chief of Police panel interview.
  - a. Committee chairs and citizens panel interview.
  - b. Police employees meet and greet session (candidate finalists only).
  - c. Board of Aldermen meet and greet session (candidate finalists only).
  - d. Mayor (candidate finalists only).
- 5. Background investigation including a fingerprint search.
- 6. Conditional Offer of Employment issued by Mayor.
- 7. Medical exam and drug screening.
- 8. Psychological exam.
- 9. Mayoral appointment to the Board of Aldermen.
- 10. Board of Aldermen vote for approval.

This hiring process in comprehensive and includes all stakeholders – including the employees. The Mayor and the Board of Aldermen agree with this process.

Although my official last day of work was Saturday, October 14, 2023, I am keeping my commission with the police department as a reserve and a consultant to the Mayor, Board of Aldermen, City Directors, and the police department. The core responsibilities of the Chief of Police have been reassigned, so they are completed. There will not be an interim Chief of Police. Major Sanders and Major Willis will remain peers in their function as Bureau Commanders. They will both report to the Mayor. The Mayor is not the acting Chief of Police; the Mayor is the City Administrator and is responsible for all employees. The purpose of this arrangement is to minimize unnecessary change and disruption during this process. The tentative plan is to have a new Chief of Police installed no later than January 2024. I understand that during this process, there will be some tension among you, and the outcome of this change is vital to the success of the police department. That is precisely why I am volunteering my time to ensure that this process is carried through to the end so the person selected as the Chief of Police is worthy of you and this police department.

This is my 25th year at the Bellefontaine Neighbors Police Department, and this organization is essential and personal to me. This organization will survive and thrive.

## Senator Angela Walton Mosley Supports Property Tax Freeze for Seniors

JEFFERSON CITY — State Sen. Angela Walton Mosley, D-Florissant, is urging the St. Louis County executive to approve a measure that would freeze property tax assessments for seniors. The county bill to freeze these rates was made possible through <u>Senate Bill 190</u>, passed by Senator Mosley and the Missouri General Assembly during the 2023 legislative session to protect Missouri seniors from paying an inflated property tax rate based on future assessments.

"I am in full support of this property tax freeze for seniors," Sen. Mosley said. "Many seniors are on a fixed income, so even a small increase on property tax assessments could prove too expensive for their budget. I am glad a majority of council members agreed that county government should not be taxing seniors out of their homes. I urge the St. Louis County executive to approve this measure and provide this vital relief to our community's senior citizens."

On Oct. 17, 2023, the St. Louis County Council voted 4-2 to approve Bill 176 to freeze property taxes for senior homeowners 67 and older whose homes are worth less than \$550,000.

## **City of Bellefontaine Neighbors Public Works**

The City maintains 52 miles of streets and supports 10,000+ residents and businesses. We currently have 7 employees in the Street Department (5 laborers and 2 administrative) and 5 employees in the Building/Planning Departments.

### **City of Bellefontaine Neighbors Portals**

The City has recently implemented two online portals:

#### Keeping Up with Our Streets

Residents and visitors should keep in mind that everyone should be aware of parking restrictions, especially during snow or ice events. Please take notice of the ordinances below and always leave enough room in the street so a snowplow or emergency vehicle can get through. This ordinance was passed in 1964 and is still in effect today:

Sec. 17-156. Parking not to obstruct traffic.

No person shall park any vehicle upon a street, other than an alley, in such a manner or under such conditions as to leave available less than ten (10) feet of the width of the roadway for free movement of vehicular traffic.

**Reminders:** As a reminder, per our ordinance all residents are required to have trash service. Failure to do so may result in fines and removal of trash containers. Trash containers should be stored behind the front wall of your property. Trash containers should be placed at the curb no earlier than 5pm on the day prior to your trash day and must be removed by 5pm on the day after collection. Grass should be no taller than 8 inches in height and yard waste, including grass & leaves, may not be left in the street. **Leaves:** Every year many people have unnecessary flooding in their basements due to backups caused by sewers being blocked by leaves and debris. Backups cause property damage and can damage water heaters, furnaces, and washers/dryers. You can help prevent these problems by getting rid of leaves and debris properly. Yard waste should be put in the Waste Management yard waste containers.

**Street Sweeping:** In an attempt to keep our neighborhoods looking beautiful, street sweeping is performed seasonally in the late fall and early spring.

**Snow Routes:** The street department does an amazing job keeping our streets open during snow events. The City of BN has passed ordinances to ensure sufficient space for emergency vehicles to serve residents and snow removal equipment to easily maneuver and clean streets efficiently. Ordinance #2096 was passed in 2008 to deem the following streets no parking (failure to comply may result in tickets and/or towing of vehicle):

- Akron, 1400-1500 block
- Avant, 1000 block
- Comet Drive, between Ashbrook and Dwight
- Delhi Drive, 9927-9953 block
- Dwight, 10151
- Hamlet Court
- Kelvin Court
- Kimball Court
- Laire, 1100-1200 block
- Larue Court
- Southworth Court
- Green Acres Road from Bellefontaine Road to Forest Home
